

We're literally pouring new technology into our world in many forms and many layers in a way that has NEVER been done before!


The next image is a look at our military radar installations which represents a literal blanket of electromagnetic radiation, and we'd still need to add civilian airport and weather radar stations as well!






This image current as of 7/29/22







# A. International Classification of Diseases (ICD-10):

Classification of electromagnetic hypersensitivity (EHS) requires two or more codes. (The WHO does not use the term "Electromagnetic Hypersensitivity." Rather they call it, "idiopathic environmental intolerance (IEI) attributed to electromagnetic fields (EMF)."

#### EHS or IEI should be classified under:

- (1) Cause Two codes are available for illness/injury resulting from exposure:
- W90.0 for exposure to radiofrequency radiation (RFR). Note this includes intermediate frequencies (IF) that flow along wires, microwave radiation (MWR) as well as millimeter waves (mmW).

#### **PART 2: Activity Limitations & Participation Restrictions**

- Activity is the execution of a task or action by an individual. Participation is involvement in a life situation.
- Activity limitations are difficulties an individual may have in executing activities.
- Participation restrictions are problems an individual may have in involvement in life situations.
- The Performance qualifier indicates the extent of Participation restriction by describing the person's actual performance of a task or action in his or her current environment. Because the current environment brings in the societal context, performance can also be understood as "involvement in a life situation" or "the lived experience" of people in the actual context in which they live. This context includes the environmental factors all aspects of the physical, social and attitudinal world that can be coded using the Environmental.
- The Performance qualifier measures the difficulty the respondent experiences in doing things, assuming that they want to do them.
- The Capacity qualifier indicates the extent of Activity limitation by describing the person's ability to execute a task or an action. The Capacity qualifier focuses on limitations that are inherent or intrinsic features of the person themselves. These limitations should be direct manifestations of the respondent's health state, without the assistance. By assistance we mean the help of another person, or assistance provided by an adapted or specially designed tool or vehicle, or any form of environmental modification to a room, home, workplace etc. The level of capacity should be judged relative to that normally expected of the person, or the person's capacity before they acquired their health condition.

The odds of your doctor associating any symptoms to EMF's is slim to none as it's just not recognized <u>yet</u>. You'll be given a Rx drug and sent back to your toxic world because they still think of radiation as a therapeutic tool. For example, when I first met Kendall on facebook, she was running back and forth to the doctor complaining of Afib (irregular heartbeat). I kept telling her to "go see what kind of electric meter is on your house." She'd read the book I published but my tech injury came after the first printing of the book. When they were suddenly burned out in the California Camp Fire of 2018 they were forced into a friend's RV for several months and sure enough, her Afib completely went away! Apparently,

she didn't need that \$800 a month Rx medicine after all. Now can you see how this "machine" can be redistributing your wealth through stealth measures?

There are many neurological disorders and diseases like dementia and Alzheimer's showing up even in children now. I'm seeing lots of complaints of Afib (irregular heart rhythms). Clots in lungs as well, may be from phones or utility meters. Stomach and gut issues seem to be the latest trend I'm seeing with new phones specifically but also a "bank" of electric meters on the bedroom wall of someone's apartment is the suspect. Recently, after Kendall got past the electric meter issue and survived adrenal cancer she again appeared to be actively dying, getting worse every day. They had hardwired their computer and had their electric meter changed to a true analog meter so her new cell phone was the likely culprit. She was complaining that her stomach felt "bad, like I'm getting cancer or something". Every day she was deteriorating. I challenged her to turn off her cell phone and not allow any cell phones in her home or in the car for at least 3 days, (not even in airplane mode which in newer phones leaves some emitters functioning). Forty-eight hours later, her health did a complete turnaround! She had her husband change all her alerts to her email and has never touched it again and she's better every day. She said this all began shortly after they were forced into upgrading their phones. She recently gave an account of having 3 ministrokes, 2 heart ablations, constant Afib (heart out of rhythm), general ill feeling, shaking, anxiety, brain issues (memory, spaciness, easily distracted), Central Nervous System issues, and later had an adrenal gland removed that was cancerous, which according to the \$25 Million government study is one of the things that can happen from exposure to cell phones specifically. She shared that all of her misery began eight years earlier while working in a business that had WIFI. I'm watching another beautiful 21-year-old young lady posting pictures of herself and they've just cut a few feet of her intestines out and she's wearing an ileostomy bag, yet there she is holding that stupid phone which is likely responsible for her having gut surgery in the first place.

When I shared Kendall's cell phone story with a local friend, she realized her stomach hurts if she's on her phone more than 3-4 minutes. She then told her 8 yr old granddaughter who said, "I bet that's why my stomach hurts when I play games on my iPad and maybe that's what's wrong with Mom's stomach and she's on her phone all the time." She also realized that one month after the utility company installed an electronic utility meter, she had a fully ruptured appendix and six months later she had a heart attack.

We have to recognize that what's being done in the name of progress, HAS NEVER BEEN DONE BEFORE. There are no ancient cell towers with microwave drums on them. As shown in the images, there's a literal blanket of military radar, which is electromagnetic radiation. Add to this the new-fangled electronic meters that are creating a "grid" aka a "field of current" that every living thing is now in constantly. Then there's everyone carrying around a transmitter/receiver they think of as their "phone." Then there's the WIFI and Broadband to be sprayed even into our rural world...an ungodly number of satellites being launched and more planned. Blatantly ionized skies...and we haven't included the gamma radiation spewing out from Fukushima and other estimated 75% of leaking nuclear plants. And when the corruption has been blatantly charted for us as you'll soon see, the only question is whether we will continue to allow what I'm about to reveal.

# It's not just wireless that's the problem

After my initial injury we bought some meters so we could trace and mitigate wireless issues, which led us into insights about wired issues as well. What was a concerning realization is to have the STATE LICENSED ELECTRICIANS we interviewed tell me, "Ma'am, if you didn't have meters to prove what

you're saying we would've thought you were crazy." So, essentially these "trained and licensed by the state professionals" had no clue that their work, done wrong, (according to personal preferences and codeviolating methods handed down by mentors), can make people sick? They weren't familiar with the meters that measure the SAFETY of their work. That is crazy!

They found a few original light fixtures in my mom's 41-year-old house where the insulation was oxidized, cracked, and left a bare wire touching the metal fixture, and yet nothing tripped. My brother noted that the electrician who did the most recent work installing a new panel seemed like he was "on something" but he didn't think to mention it. Maybe they should be passing a drug test to keep their license. The electricians never did find where the house was grounded. It was purchased AND inspected in 1988, built in 1976. Checking for a healthy ground should be on that list of things to be inspected. The night the electricians installed two 8' copper clad grounding rods and a number 4 wire from the electric panel, I slept for 5 hours straight for the first time in several years, maybe since moving into that house with my widowed mother in August of 2012. Who knew that interrupted or inability to sleep could be a home wiring or electrical issue in the environment or from the type of electric meter on your home? Anybody? Your doctor?

We found that the sprinkler system on the outside wall of the fireplace was throwing a dangerous electric field half across our living room where we spend several hours of our evening. There was another dangerous reading running along an entire wall, so we had to open the sheetrock and found a common problem; a staple slammed into the Romex at an angle by a high-powered stapler. I'd learned that even if the insulation isn't broken the wire can sustain an injury and throw a field off into the home and did! Then the Romex was pulled at a 90-degree angle **tightly**, another no-no that can result in a crimp in the small wires and throw off a toxic field and did. There was a screw in a 220 cord behind the stove that a contractor had done and that too can throw out a very toxic field and did. Add this to the appliances running, LED lights shining directly on granite counter tops, which store and transmit energy, and you might understand why being in the kitchen felt like I was being subtly electrocuted! This could easily have led to a wrong medical diagnosis, a wrong treatment, my early demise, and a remaining toxin pouring into the home. Just like carbon monoxide you can't see it, taste it, or smell it but it will create disease and even kill you. I think it's time for an EMF inspection to happen at homes prior to occupancy and perhaps at sale. Certainly, public education needs to happen.

As we continued to unravel, eliminate, and remedy the mass amounts of electrical chaos going on around us and having to train the electricians, while learning ourselves, I kept wondering why nobody in our culture encourages the maintenance and health of our electrical environment and the understanding that it can and does affect our health? Are we really that ignorant? Sadly, the answer is "Yes" and I was about to get a further education and become burdened with the task of waking up humanity.

# THEN, IT GOT REALLY WEIRD AND IT WASN'T JUST ME, THE 'SENSITIVE' ONE BEING AFFECTED!

**June 9<sup>th</sup>, 2018,** while standing in my back yard, I had a very abnormal experience. It felt like my eyes were going to cross but then the sense became that they were attempting to line up vertically lasting for about 5 seconds. I recall everything turning white but muscularly speaking <u>it seemed</u> that my right eye was vertically above my left eye. I got a little woozy but recovered within a few seconds after it stopped. I wasn't sure what to think about it but considered that I was wearing rubber flip flops, so I wasn't grounded

to the Earth, was now hypersensitive, and standing .27 miles from a large cell tower. Not being grounded to the Earth meant that any wave form in the area would see me as an upright water filled antenna. I wondered if it was a new symptom of me being "electrohypersensitive" but felt we were doing everything we could do so I went on with my day knowing that most answers usually find their way to me and sure enough...

June 11<sup>th</sup>, 2018 (2 days later) a similar thing happened to my then 82-yr-old Mom while she was standing in the doorway of my bedroom. She did not know it had happened to me and she is NOT electro hypersensitive!!! Somewhat differently, she described that both of her eyes seemed to go in opposite directions side to side and hers lasted for 5-10 seconds. I can't help but wonder what might have occurred if this had happened while she was driving her LARGE motorhome? Likely it would've been blamed on her age and her driving privileges taken while the larger issue was ignored! BUT WAIT...

**THEN,** I met an electrical engineer in the local grocery store a few months later that seemed like an appointment with Destiny. He followed me out and bought a book from me and gave me his card. I called him about six weeks later and we talked for two hours, and he told me that he too had this vertically aligned eye event **but his lasted for several minutes and there were witnesses.** He described several friends at an apartment working on their computers together for a project. At the end of our phone conversation his voice began to quiver, and he said "I say with all humility that I am often the smartest guy in the room. I wish that what you are saying weren't true because it means that we missed something very important in our deployment of these things." He then cried and said, "But I know it is true and frankly, I'm scared." My reply, "You should be scared. Very scared!"

I went to NextDoor.com via Mom's account, and sure enough, there's a post there ON **JUNE 9<sup>TH</sup>**, 2018 that showed the new traffic light at Hudson Loop is now activated "be careful, heads up" kind of post.

I found the following article that begins with "Migratory birds are known to use the geomagnetic field as a source of compass information. Scientists have shown that oscillating magnetic fields disrupt the orientation behavior of migratory birds. Researchers found that robins were disoriented when exposed to a <u>vertically aligned</u>, broadband or a single-frequency field." THAT would explain the sense I had that my eyes were aligned vertically! It continues with a quote 'According to Alasdair Philips of Powerwatch.org, medium- and short-wave frequencies have been used since the 1930s with little evidence of any effect on bird behavior. But since the mobile phone networks went up there have been increasing reports of birds, especially homing pigeons, getting lost. Research now needs to look at the effects of base station signals, particularly in view of the disorientating effects of EMR 'noise' reported in this study.'...Your body is also dependent on appropriate chemical reactions, many of which are guided by electrical frequencies in your brain, some of which happen to oscillate at the same frequency as that of cell phones and wireless networks." Some quick research revealed that birds have magnetite crystals that help guide them. Several sources acknowledge that we <u>humans also have magnetite crystals in our eyes and our brain</u>, so it doesn't take a high school graduate to see what happened here. A man made or "non-native" wave form passed through our body and the magnetite crystals (iron + oxygen) caused our eyes to line up with the signal as it passed through us.

June 13th, 2018, I ended up being stopped by that new traffic light at Hudson Loop and Hwy 290 West for the first time. Now mind you I was sitting about 150-200 yards from two new apartment complexes that are outfitted with hundreds of these new digital electric meters, likely of the wireless design. I'd read from a few sites on the internet about how these meters are pumping out pulsed microwave radiation, 24/7 and that they all produce a horrid amount of dirty electrical current that rides on the 60 Hz sine wave that brings electricity into our homes and radiates out into the rooms. We had a 13-year-old version of this technology on the home in Austin, but we had it changed out to an old-style, mechanical only, "analog" meter like most of us grew up with. We had to pay \$75 to change it and an extra \$30/month to have someone come read the meter. This practice has been ruled as prejudiced against the disabled to charge fees to have equipment that doesn't make us sick, but nobody wants to admit it's making people sick. We can deal with that later; right now, I'm just trying to survive the plight and get the word out to others so we can change the course we're on. After we had it changed out, I could tell that my body felt less burdened and again slept deeply for two nights but after a few days it seemed my progress stopped again, and I realized that it wasn't going to get any better from this change but at least it was one more source tamed. I also realized our neighbor's meter is about 20 yards from where I spent the bulk of my time in the home, including my bedroom and the office. In a typical subdivision every neighbor has one of these on their homes so there's no escaping it, unless I educate my neighbors and convince them to switch out their meter too. I could only hope to reduce the dosage where I had options to do so.

As I began to learn more about what's around me, I began to understand we're being saturated in this stuff but at the moment I was sitting at that traffic light I had no idea that I should be concerned as the extent of my knowledge was more experiential. As things happened to me, I'd go looking for the academic side of the story and because I'd been driving in front of those apartments for a year now without issue, I had no idea what was about to happen THIS TIME when I was stopped at the light and couldn't move. I was horrified as I felt my body being saturated with toxic energy. Remember radiation effects accumulate in the body. So, touching the screen of Mom's phone at a point when my body was already saturated threw me into an acute situation that tilted the scale. By the time I got home, a mile away, I was wanting to leap out of my own body. I got my bare feet on the grass quickly to pick up free electrons to calm the biological storm. Yes, we've also forgotten to implement good "grounding" practices as we've electrified our world. (Read the book Earthing by Clint Ober, (second edition) backed up by a cardiologist, Dr. Sinatra, whose son developed severe Electrohypersensitivity aka EHS.)

Over the next few days my sensitivity amped up to what I estimate is triple what it had been from that single exposure event. However, it was this event that drew our attention to some new technology (a white rectangle plate) plugged into the metal arm that traffic light is mounted on. I have no idea what it is but there are now two of these at the next intersection of Scenic Brook, west of there, and <u>SEVEN</u> of them at the next intersection of Circle Drive and Hwy 290 West, and a 4' antenna of some sort too. What is this, how many is too many, and what all is it affecting that we don't know about? Is it broadband that makes the eyes cross or float?

I went to AntennaSearch.com and learned that we had 23 cell towers and 112 antennas in a 4-mile radius of our home, though I only see a few. (Be aware. In tiny print on this site, they have now reduced

this to a 2-mile radius so the numbers may be different, and it may change again). I thought that was a lot until I reconnected with a friend, I'd lost touch with after I became ill. She too is now sick, and we both used to be in abundant health. I looked up her address and there are <u>443 cell towers and 339 antennas</u> around her in a 4-mile radius! They chose her home to put a data collection meter on aka "Medusa" and all that implies. It collects data from up to 17 homes and sends them to this meter they'd installed on her bedroom wall with high levels of radiation coming out the back of it.

Last time I investigated it, most of these new utility meters aren't even approved by Underwriter's Laboratory. Your toaster and hair dryer has a UL code of approval but not these and they plug into our power source? When they came through and installed those "Smart Meters" in her neighborhood built in the 60's, they blew four transformers in four months! The governors are content that the installed equipment complies with the relevant regulations." I can't emphasize the number of insane comments like that I've read by school officials and

# "So Where Are the Cancer Clusters from the Cell Towers" I wondered.

With my new awareness I start noting that cell towers are now literally in the back yard of some homes, at schools, and on top of apartment buildings where children live. Initially, she was reporting 10 kids with brain cancer within two blocks of the school. In a few weeks, she updated the information that now showed 16 kids and 9 adults within two blocks of this cell tower have or had cancer. As she and another parent continued surveying their neighborhood the story became a horror show and **she** 

recently emailed me a list of 82+ people with cancer within a five-block radius of this cell tower, and two more; 21 of these cancer cases are children!

Simultaneously a search online shows the public health office and even the University of Chicago have studied the issue and listed in one article the increases of the various cancers but stop short of admitting to a "cancer cluster." What I've learned is "the machine" is perpetually looking for things they never really find and never really respond to; much like the Michigan lead in the water ongoing "non-crisis," the violent school, the mental hospital and the electrical concerns from the 1930's. The articles refer to what these women did as "anecdotal evidence", but I can't see how going door to door with a survey and asking "Do you or anyone in your home have cancer? When? What kind? # **Cell Phones**



Wired circuits are insulated wires and the EMFs cancel each other out. Wireless circuits are not insulated and everything hit by the EMFs is in the electrical circuit.

Health Canada's Safety Code 6, FCC and other governing agencies adopted the Specific Absorption Rate for testing. The picture on the left shows a test model used to represent humans and adverse health effects. "Can you see the eyes, brain, organs, heart, nervous system, cell structure, voltages, frequencies, electrical changes?" Can you see different considerations for the size of person in the EMF or their movements within the EMFs?

It's an offense to the issue of "safety." If it is to imply the surface of the skin only, it is still inaccurate. The entire body is atoms and molecules(energy) SUBTLE ENERGY where magnetic, or EMF interaction can have a profound effect.



These fillings actually release mercury vapors continuously as hot foods, liquids and the abrasive act of chewing occur. **They also produce a high voltage**, which means that people with this material in their mouths are actually MORE susceptible to the hazards of radiation **and have more "antenna-like" qualities**. Remember, it amplifies metals! Given the right genetics, you have a recipe for a health crisis. There are many disincentives for a medical professional to acknowledge this! I had my dental fillings revised in 2005, spent \$5000, and spent 18 months detoxing my body the best I could but have no real assurance that the impact is all gone. In fact, I think it imprints the body and weakens the host compared to what they may have been without it. Again, this knowledge is ignored, and corruption buries the chances of justice.

"Oh no that can't be true! That's crazy!" Really? Crazy like bringing in asbestos, chemically tainted tobacco, Thalidomide, DDT, GMOs, Operation Paperclip, The Tuskegee Experiment, or letting corporations grease the palm of our legislators, or allowing politicians to reroute a portion of foreign aid to themselves through their kids or take contributions from corporations in exchange for "donations"? When did we forget that we shouldn't trust the government?

If you go to YouTube and type in "The Smoking Tooth", Dr. Layton, D.D.S has a 3-part video, each just a few minutes long: https://www.youtube.com/watch?v=fJVBYZEsqEU&t=200s. One of them has footage of a sheep they put mercury fillings in its teeth and then later x-rayed and showed where all they measured mercury in its organs. We learned this in The Mad Hatter story, didn't we? Preserving beaver pelts with mercury made the makers and the wearers of the hats go "mad!" I saw a dozen doctors in 18 months and every time they, or the nursing staff said "Open your mouth and say 'Ahhhhh" the answer was staring them in the face, but they simply weren't trained to see it or to think to look for previous "human intervention" or consider my genetic leanings. That's how out of touch our medical world is. They are completely blind to some information. They should be taught to look for any human intervention in the body as a possible source of illness as well as their patient's diet, relationships and environment as few health issues are a Rx drug deficiency but "if the only tool you have is a hammer, everything starts looking like a nail". Next is an image of The Interior of a Eukaryotic Cell. Can you see what looks like electric circuits? On page 2 of that Canadian Initiative for Safe Wireless...the opening article "What is Electrohypersensitivity" site states "Because the body of evidence is only now being taken seriously, most family practitioners are still unaware of EHS or anything that is involved in treating it."

The Canadian Initiative to Stop Wireless, Electric, and Electromagnetic Pollution site <a href="http://www.weepinitiative.org/livingwithEHS.html">http://www.weepinitiative.org/livingwithEHS.html</a> states on page 9, "Not only do amalgam dental fillings attract EMF and electricity to your body, they create electrical current, and they contain mercury. Mercury is very toxic and is difficult for the human body to process and get rid of. Heavy metals in your body may have contributed to your getting sick in the first place. There are many ways in which you could have acquired heavy metal toxicity, but dental amalgam fillings are a major source of contamination. It is not a single incident contamination but an ongoing leaching into the body."

This same site states on page 4 that those affected should "LIVE AS FAR AS POSSIBLE FROM power lines, distribution lines, electrical substations, electrical bus cables <u>and cell phone towers</u>." Uh huh. So, what do we do about the cell towers, antennas, and a microwave grid of electric meters put around us?

In this presentation I've provided several articles that establish this to actually be a disabling environmental disease according to several countries, several medical authorities, scientific groups, and beyond. In fact, it was hard to pick what to include in this story as I could easily have cited a train carload of published studies on harm. The days of "There's not really any science to establish harm from technology" <u>ARE OVER</u>, wireless or wired! And once you head down this corridor and see what we've allowed, you should be horrified.

"As the objective evidence of the physiological effects causing EHS becomes convincingly established, there is increasing worldwide legal action on behalf of people with EHS. Studies since the 1930s are now showing a consistent weight of evidence confirming the specific symptoms of EHS, also long known through geomagnetic studies and electronic warfare since 1953. Since 1982 in the US, and since 2011 in Europe, courts in many countries have accepted the reality of physiological EHS along with non-thermal EMF effects and made awards and compensation for people with EHS including awards against those businesses responsible for the excessive radiation."

The above quote is the opening paragraph from <a href="http://www.electrosensitivity.co/legal.html">http://www.electrosensitivity.co/legal.html</a>, a site I've been pouring over for several weeks. <a href="https://www.electrosensitivity.co/legal.html">It's DENSE with content specific to the legal issues establishing this to be a "functional impairment" and/or a "disability" with global content, lawsuits won, countries who have implemented Wired-Only connections in schools and accommodated those disabled thereby setting precedence, just not in the sold-out to corporations US gov't. It lists several states that are introducing bills requiring "Safe Zones" and "Wi-Fi Free" areas much like the "Non-Smoking" laws. It's getting a little harder to ignore the stark realities of where we are! So, are WE THE PEOPLE going to protect what remains because the same government that allowed this isn't likely to also save us.

Here's another excerpt from this site:

"Informed consent is <u>required</u> for experiments on humans involving non-ionizing and ionizing radiation. It appears that some countries like the US try to evade this requirement by claiming that such experiments, even where they cover large populations, come under 'classified research'. The irradiation of the population by cellphone towers without prior testing, where any adverse health effects will be discovered as a result of this irradiation, is often regarded as an experiment on the population without informed consent."

I found a **Public Law 90-602** — October 18, 1968, document online. (Exhibit E) **The stated purpose of the law is to "amend Public Health Service Act to provide for the protection of the public health from radiation emissions from electronic products."** Apparently, we're going to ignore that too! I'm currently looking for the new law or amendment that says "Never mind. Radiate the public... as long as you contribute to a politician's campaign. Have I been tested to confirm my diagnosis? Well, since there are only a few clinics throughout the entire world that are willing to admit, much less venture to treat this condition, coupled with the reality that these clinics require cash payments that 99% of people can't afford, and I've been unemployed for almost 6 years, the answer is no. So how do I know that I have it or how can I convince someone else that I have it? Well, I have a "Body Voltage Meter" that measures my body's reaction to its electrical environment. In Austin, we had granite countertops in the house, which we've now learned can emit a small amount of radiation in the form of radon gas. I was testing everyone that came through the house for a while. Anyone

who touched it saw their body voltage would increase. My body typically gave a reading three times higher than anyone else and that was from touching granite. If I got in a high EMF environment the readings would again be three times higher for me. And when I step on a grounding mat, my body voltage drops way down proving that my methods to protect my body are in fact working.

There was the time my mom, sister, and I were going to dinner. I can't ride in a car with a cell phone on (neither should anyone else) and always step far away from any cell phone in my presence; they make me hurt and feel ill almost immediately. So, everyone reported that their phones were OFF. We got a few minutes away from the house and I started feeling ill and asked, "Are you both certain your phones are off?" They both replied "Yes" and immediately my mom's phone rang. So yes, I can feel it even before it rang, I was feeling the signal coming in! Another time I was helping my sister move from a storage unit and never felt anything from the tower in sight at a distance but when a daunting depression hit me for a week and I finally made the connection I realized I was in fact being affected, whether I felt it or not at the time of exposure. Different frequencies reportedly cause different symptoms so you might understand why this toxin would be hard to pinpoint.

Another point is made in the Generation Zapped movie at the end when the wife of a man who has this condition says, "If you think these people are faking it, come live with them" or something to that effect.

# **Problems With the New Electronic or Digital Utility Meters**

Okay so that's just a few of the issues at hand. Let's talk more about these new-fangled digital electric meters being put on people's homes without their fully informed consent. They've been outlawed, recalled, and are being widely investigated! This is the video that cued me in that something illegal was going on. Somebody has an agenda because they were hiring contractors to install them who were kicking in basement doors and cutting perimeter locks to install them without the customer's consent or knowledge and in fact, often in spite of objections. The Province of Saskatchewan (Canada) <u>ordered the removal of 105,000 meters</u> following a rash of fires. Portland, OR, Lakeland, FL, Arizona, and Ontario followed suit. There is currently an effort by Curtis Bennett in British Columbia <u>to recall the entire program in Canada</u>. His website is Thermoguy.com and he's an expert on these meters and declares adamantly that they are a violation of building codes and are <u>illegal as applied</u>.

New Mexico has rejected them in ALL of their metro areas.

Michigan has a massive citizen effort to get rid of them.

The state of Virginia just rejected them statewide.

Montana has just rejected them as well.

80 of these "smart" meters ignited from a power surge in Palo Alto, CA in 2011.

Massive recalls and rejections of this technology are happening in Europe as well. Fires, explosions, health concerns, and privacy violations are the biggest issues.

The source article cited above states other issues with the meters including that they" ... <u>emit pulsed</u> <u>microwave radiation typically thousands of times stronger than a cell phone, leaving many unsuspecting homeowners feeling ill." [emphasis mine]</u>

Another Source: <a href="http://emfsafetynetwork.org/smart-meters/smart-meter-health-complaints/">http://emfsafetynetwork.org/smart-meters/smart-meter-health-complaints/</a> has 232 pages of health complaints from electric meters and now the cities are bringing in "Smart" water and gas meters too! Are we going to ignore the 232 pages too?

Another site helped me get a visual of the amount of radiation from these meters throughout a neighborhood, how they work, and why they are harmful. SmartMeterEducationNetwork.com from Michigan where they use a wireless electric meter. The site explains that Smart Meters emit "...the same waves that cell phones emit, but smart meters broadcast 24/7 at a power density 100 to 160 times that of a cell phone...and smart meters generate dirty electricity (line noise) which is as harmful to health as the wireless radiation the meters emit...Analog meters do not require electricity to run and are more energy saving...can't be hacked...do not generate harmful dirty electricity, unlike most, if not all digital meters."

Still in Austin...there were two more apartment complexes being built that could make me even more sick due to their proximity AND they will no doubt be outfitted with these same meters; 273 of them on one complex. This new complex is about 200 yards from where I was stung by a rogue current and my sister another 150 yards beyond. There's a HUGE cell tower near this complex too about 100 yards from Gorzycki Middle School and a small electric substation. I'm very concerned about the people living in this toxic soup but also about my own wellbeing! Will I too have to flee or live in a metal shed in the back yard or a shielded room? Yes, we fled to the Arkansas Ozarks and yet another mission was born! Stay tuned.

Again, Curtis Bennett warns, "...There is 900 MHz and 2.45 GHz interacting with 8.3 Hz or .1 Hz of the brain is crashing the human electrical grid plus much more...<u>FortisBC's own Electrical Engineer Lindsey's quote at a meter swap in Kelowna that 900 MHz of the smart grid interacting with 8.3 Hz would create ALL kind of harmonics.</u>

The 8.3 Hz is one of the frequencies of the brain and an admission of adverse health effects."

This could explain why they've built THREE memory care centers within minutes of our Austin home in the last few years. My neighbor recently told me that they have <u>SIX</u> friends in their inner circle with dementia and their 56-year-old son just got diagnosed with Early Alzheimer's. I have a picture on one of my Facebook pages of a large billboard promoting the Children's Alzheimer's Foundation and there's now such a thing as Pediatric Dementia. What's so sad is to watch the medical professionals act bewildered knowing they have no clue what kind of technology is around their patient. Hopefully, this little booklet can change that. The Earth has a pulse that matches the human brain so when we clog up our atmosphere with electrosmog we also impair brain function. It's great for business if you want to open a six-story memory care center and sell Rx drugs but if you want a healthy populace and healthy pollinators then perhaps this is a horrible idea.

It was in a phone conversation with Mr. Curtis Bennett (Thermoguy.com) where I learned that our utility provider (PEC) recently switched our meter to an analog, and it was done "under full load" in violation of

professional standards and maybe more. I watched it happen but didn't know any better. He also pointed out that according to Texas Construction Law the only person <u>legally</u> able to change a meter out is a licensed electrician. I'm betting that's NOT what I saw done here at our home. Mr. Bennett made the very valid point that at this appointment the homeowner should have their own professional electrician to inspect and perform any maintenance as the utility company can't legally touch the stab connections, which belong to the homeowner and the homeowner can't remove their meter to inspect them. In fact, this meter had not been off the house in 13 years. I can't help but wonder if there's a professional standard or if it just typically isn't adhered to in the industry. Again, having an electrician representing the homeowner would be a good protective measure for everyone, though cost-prohibitive for others. Of interest, The Seventh Circuit Court of Appeals deemed that it is ILLEGAL to collect usage data even if you never do anything with that data. To collect it constitutes "illegal search" ... you have to have a warrant. PERIOD. So, every day data is collected is a violation of the law but we're apparently going to set aside this law too now to accommodate technology! Forfeiting civil rights to accommodate technology is a bad idea! I couldn't find an Underwriter's Laboratory Code for the one's in use here which is a safety accreditation. When I inquired, I was told by Carroll Electric Cooperative Corporation that "they meet ANSI standards" as if that was supposed to allay my fears. My thought in response, "With the readings I'm finding here that tells me that ANSI is compromised." So, I went looking for evidence of that accusation. Sure enough, I met a man online who made many videos about the insanity of our safety certification oversight agencies in the US and globally, and one video showing that ANSI was being

overseen by a member of the CCP (Chinese Communist Party) from 2015 to 2021. He detailed that any member of the CCP has a "duty" to collect data for them. When you add the fact that 501C4 "Dark Money" is allowed in our electric industries, meaning the contributors aren't revealed, and the fact that many of our politicians have sold their soul it gets very concerning!

The picture above should be shown to our home insurance providers. Maybe they'll help us get these off of our homes since they'll have to pay for the damage! It's a subdivision and every house burned to the ground that had an electronic utility meter and the four homes with an analog meter are still standing. Someone on Facebook commented they are friends with a woman, now an author and speaker, who was in this kind of story in her subdivision so now I have a person to back up this image.

Every provider asserts their equipment is somehow "better" than a "Smart Meter" or better than another utility company. I've yet to see that statement supported and that does not mean they are inconsequential in the pool of contributors, IT'S ALL OF THE ABOVE, the radar, the towers, the phones, the utility meters, the satellites, smart devices of all kinds...so we need to make some choices. And so far, every utility company makes the same claim that their meter should be above scrutiny. Uh huh, says who?

Power lines by themselves have "consequences" that we accept to have power and we should look at any methods that can improve what they are but when you add the "wireless" aspect of what we're doing there's a qualified need to retest what you've deployed to see how they play together. Likewise, when we have analog, mechanical only meters, that don't cause issues we need to be using them and eliminate this

contributor to the overall radiation load in our environment in addition to hackability, privacy invasion, and they're being subject to fires and explosions.

# We Fled to the Arkansas Ozarks and Yet Another Mission was Born

Though our family founded Blakely Town, now Arkadelphia, we'd always lived in Texas and didn't know Arkansas was "The Diamond State" until we began our search for a new home. We both thought Jasper was someone's name until the seller of the home said, "For some reason I feel like I NEED to tell you that Jasper is a gemstone." I laughed because I knew why. God wanted me to know I was sitting exactly where He'd told me I'd be, 31 years ago. That means He knew what He was going to teach me and perhaps knew that you would be reading this and would be willing to help HIS MISSION. *This moment matters a great deal*.

#### Let's connect some dots:

November 2019, we arrived here.

December 2019, 46-year-old Staci Wheeler died reportedly of a heart attack. The husband has not responded to two email offers to borrow our Stetzer line noise meter to check his home's electric outlet readings. This death is considered highly suspect that dirty electricity from the electric outlets is to blame but we'd just arrived, so I didn't get it until...

December 2020, 60-year-old, Lesa Tanner Massengale, was found with multiple masses on her brain, same side of her head as an abnormally high up on the wall electric outlet by her desk. We found deadly readings coming from that electric outlet which was even with her head at her desk and throughout the office area. The brain masses were on the same side of her head as that outlet. She died three weeks later. THIS was the event that yanked me out of the notion that I was some rare individual being adversely affected. I realized then that other people just didn't feel it but instead they get hit with a major symptom onset, bad diagnosis, or drop dead.

A letter was distributed widely in town attempting to make people aware of the DEADLY READINGS found at that electric outlet and throughout buildings in town. One person responded in a personal capacity, not officially through his office, encouraging me to contact the Newton County Health Department. I was confident that people were at least talking about the issue and in time, they'd see and respond. **Then,...** 

December 2021, 54-year-old, Candace Sexton, another beautiful healthy soul, dropped dead of a heart attack. *MAJOR CLUE*: Lesa and Candace both worked in the same building where the first high readings were found in public buildings; the hardware store, lumber yard and grocery store. They died 13 months apart.

I have no idea why it's December, but we're 3 for 3 now. We can speculate that holiday lighting and extra demand on the "grid" could be causing some unknown electrical surges. There's a link to a 5 min video a few paragraphs down that covers this reality.

We have to admit that while lots of new tech has been brought into the world, we have failed to also provide alarm systems to tell us when toxic levels are unsafe, like a carbon monoxide detector. Perhaps that's why God sent me in. I'm a walking, talking, researching, and typing warning meter SENT to show you what's going on.

So, let me share some things about electric meters in general: First you need to know that the electric power coming into a utility meter on the electric lines used to be a smooth 60 Hz sine wave like you see in the image below on the left. It passed through a non-electronic, mechanical only meter, which measured the amount of current that flowed past it by turning a horizontal wheel with teeth on it that then clicked the little clock looking analog dials, which turned some numbers and that was our wattage usage charted monthly to determine our electric bill we had to pay. No electronics were involved so the 60 Hz wave was just a nice smooth wave coming out of the other side of the meter into the home/building. When the utility companies decided to use this new technology, it radically changed this smooth wave coming into our buildings as it now has a chaotic signal that rides along it as you see in the image on the right, but nobody warned you. This chaotic signal can be measured on a meter and should be filtered to a reading of 30 or lower, anything over 50 is undesirable and must be filtered.

If you go to <a href="https://nomoretowersintheozarks.org/images-that-teach">https://nomoretowersintheozarks.org/images-that-teach</a> you'll see a screenshot (4<sup>th</sup> one from the top) where it's disclosed that a Dr. Tell admits the meters he tested for Itron, were only tested for functionality, or their ability to transmit data, and were never tested on humans or animals. This is just one form of meter by one company, but I suspect this is true of all of them.

In the image below, where he shows a plug, that should be an electronic meter in my description, but you get the point:



When something disturbs its standard flow, it creates micro-surge electrical pollution, commonly known as dirty electricity.

The creator of the site above then goes on to ask and answer, Where Does Dirty Electricity Come From? "As a baseline, let's think of regular old 'clean' electricity as smooth. Just as electrical wiring and the power grid can conduct electricity from the utility company so can it conduct other electrical signals and other forms of EMF. Two types of this unwanted EMF include transient voltage and wireless gadgets. It is these forces that convert 'smooth' electricity we expect into unpredictable, 'dirty' electricity. And once these forces are created, they spread throughout a building – and even to other buildings – over the electrical wiring and power grid, radiating potentially harmful EMF into our environments."

Part of the "process" of inserting this now electronic/digital technology between the powerlines and our homes, offices, schools, hospitals, nursing homes, they refer to as "stepping down" the voltage from 220

volts coming on the powerlines to 4 to 10 volts. Nice little term they have there "stepping down" but in functionality, this is like putting lightning in a box and is what you see in the above image on the right. Smooth on the left coming into these new meters of many brands and designs and DEADLY after it passes through their meter, BUT THEY DON'T WANT YOU TO KNOW THAT because they'll have to correct a very expensive mistake they made!

Another reported problem has to do with what's called a "switch mode power supply". It's the program that switches the devices from DC or direct current to AC or alternating current. In these meters it does this over and over and over. I would assume with my somewhat limited knowledge that it's this process that creates the dirty electricity and that the meter won't work without it. The same is true for an inverter on a solar system, it converts to AC from DC and when it does it produces high levels of dirty electricity.

You also need to know that the utility companies constantly misrepresent facts and tell people that their meters only send data 4 to 6 times per day. That detail may be true as far as reporting our usage, but they left out some pertinent details as these meters are in CONSTANT communication with the system at large. The system asking of the individual meters, "Are you there? Everything okay?" The meter then replies "I'm here." According to one lawsuit this takes place anywhere from 9600 to 190,000 times per day! The kind of metering system in use here is questioned on one site as being "the worst form of smart meter" known as a TWACS (Two Way Automated Communication System). Details about this "power line communication" (PLC) system are worth noting from this source. "Ours isn't wireless" if you mention being concerned about "wireless meters". And again, these hardwired one's are questioned as being "the worst" so "ours are hardwired" or "carry data over the powerlines" doesn't mean they're safe and have no issues. They're playing mind games with you to make you go away and stop asking questions. I've found that they will not make you go away and stop asking questions. I've found that they will not make you go there. Most people never get past this initial phone call and limp away from the conversation. That's why I'm writing you a book to teach you what they won't tell you so we can change this.

That site also details how it "contaminates" the powerlines with constant pulses. Other EMF remediation specialists commenting on this kind of TWACS/PLC system have pointed out that the powerlines were designed to ONLY carry electric current. Using these electric lines to now carry data, which they point out 'has an inherent whine', could explain the 24/7 high-pitched squeal in the air here. She shared, "The Austrian Chamber of Physicians (equivalent to the American Medical Association) and the Swiss Physicians for the Environment were so alarmed about widespread health effects from PLC that they opposed it at the federal level in their countries. Effects can be immediate as well as cumulative. Reports from states that have this indicate this is potentially deadly, with the most vulnerable feeling the effects soonest."

After the last death, Candace Sexton, who worked for many years in the same building as the 2<sup>nd</sup> death, the "letter to Jasper" was expanded and distributed throughout town again. To the official offices noted

below and we also included a \$150 meter to take readings, a \$35 filter just for demo purposes, and 2 small books by highly credentialed experts to support the accusations. One booklet is by an MD; epidemiologist, and the other author is a retired microwave weapons expert. The packages were presented to the Fish and Game Office, the Newton County Judge, Warren Campbell, and the Ozark National Forest Office here in Jasper. Later this package was mailed to The Newton County Health Department and followed up with emails sharing more developments and concerns. June 20<sup>th</sup>, 2022, I received an email from their office that "we have decided to share information with the doctors in Little Rock over us". For clarity, this means that Dr. Jacky Dunn, Chief Health Officer of Newton County Health Department decided it needed to be reviewed further with the doctors over the county health office. THAT should matter. Sadly, Dr. Dunn got sick shortly after that and passed away before doing so, but he did deem the information worthy of further review.

The meter readings in this house, our neighbors, and other buildings in town would be considered "dangerous", maybe DEADLY is a better choice of words. So, when Lesa Tanner Massengale, of Bob's Do-It-Best Hardware, was found crawling on her knees and didn't know who she was due to 5-8 masses (differing accounts), on the same side of her brain as an electric outlet, which was unusually high up on the wall, even with her head while sitting at her desk, I went to take readings! Ideally this reading in the electric outlet should be around 30. No reading above 50 is acceptable on a "Stetzer" meter and "must be filtered" is what the package reads. This meter measures voltage surges or "line noise" riding in on the 60 Hz smooth sine wave electric current from the power line. It's been around since the mid-70's and measures what's commonly known as "Dirty Electricity" considered "very deadly" by Dr. Sam Milham, author of Dirty Electricity... <a href="http://sammilham.com/">http://sammilham.com/</a> Remember the opening line of his book reads, "I am writing this in a desperate attempt to warn you." One of these books was included in the package.

The readings taken in the hardware store here in Jasper started in the 1500's, jumped to 1900's then exceeded the limits of the meter which is 2000 GSU's (Graham Stetzer Units). I went next door and found the same to be true at the lumber yard, the grocery store, the physical rehab building next door was lower, but they weren't open which matters, but it was still over 1000 on the front porch. Another longtime local took the meter and measured their home (it was high) and then took it downtown. He came back very discouraged reporting "the Courthouse is high...the...well, every building I checked is high, but I don't know what we can do". He looked very disappointed. I shared that if the utility company claims to be "member owned" then that says the members get a say BUT then you'll also find that according to many locals and a somewhat recent lawsuit I found online, CECC locks said members out of public meetings and changes rules to control who gets on the board. This is deadly, criminal, immoral, illegal behavior and is NOT the way people treat each other or God's creation.

The 24/7 High-Pitched Squeal It's Not Tinnitus!

As for the 24/7 high-pitched squeal in the air here, it's not tinnitus because it never varies in tone or consistent presence, only in density of presence. I didn't notice it for the first two months, now I can't NOT hear it. When I began inquiring, many locals say they too hear it <u>and</u> that it began immediately after they installed these new electric meters here. One local man was zealous in his answer and almost angry about how it wakes him up and how he's noted that his health has really headed downhill "since I moved into that house..." I have not checked his home readings, but someone should. I estimate that one-half of the people I've asked hear it. Some seem not to notice until it's pointed out and then realize they are hearing it. It can sound like insect background noise but more invasive and "tinny" sounding.

I was able to find a 70-year-old Chief Inspector for the Board of Electrical Examiners and Licensing in Little Rock, Dept of Labor, Charles Covington, who stated very zealously, "If y'all are hearing that it means there's a problem!" He told me that his office "doesn't have any jurisdiction" but said that he would call an engineer colleague at Carroll Electric and ask him to come check on this. A year later I let Mr. Covington know that nobody has been in contact in any way shape or form. He again requested the matter be checked into and when I spoke to him again in September 2021 and learned that he was retiring October 1st, I told him that I'd been sharing widely of his declaration that there's a problem up here and asked if anyone had confronted him on that. He laughed and replied, "Yes they asked me why I would tell you such a thing" and with gusto he said, "I told 'em 'BECAUSE THERE'S A PROBLEM **UP THERE!**" He never backed down and I do find it disturbing that whoever was questioning him wasn't concerned about public safety but wanted to know "why he would tell me that "there's a problem". He gave up the name of the engineer he'd contacted twice as Randy Hooten. He seemed a little angry that Randy and CECC had done nothing and since he was retiring apparently felt no obligation to protect them any further. I'm certain this is an inconvenient issue so CECC would just rather not bother, but that's not an option as I see it. Intelligent, moral, caring people pay attention to safety meter readings especially if they are the emitter!

There's a link on the "no more towers" site titled, "This is not 'tinnitus of unknown origin'! It's microwave auditory effect. We're actually hearing frequency in the air known as Vibroacoustic Disease or VAD. I don't understand why it has to be called a "disease" since those of us hearing it aren't "sick", it's an environmental noise pollution created by their metering system! I will say however, it's this article that has me concerned for my long-term health due to this "squeal" as it discusses how damage was found at autopsy on someone subjected to this. "In 1987, the first autopsy of a deceased VAD patient was performed. The extent of LFN (low frequency noise) induced damage was overwhelming, and the information obtained is, still today, guiding many of the associated and ongoing research projects. It then goes on to talk about "Assault by High Frequency; a Tortured Life, a Tortured Death". In fact, that's what the Chief Electrical Inspector said of being subjected to a "24/7 high-pitched squeal" I called him inquiring about. "That's a form of torture".

## **Corporate Bullies!**

At that link you'll also see a pm from a 90-year-old woman who, like us, had to flee from her home of 54 years because her 62-year-old daughter couldn't handle the smart meter Nicor Gas was going to install

on their home. "What needs to be told is how we legally tried to stay in our house, but Nicor gas Co could legally put a condemnation on the house if they shut off the gas because of the new meter etc." Is this what we want happening? Are we going to let utility companies drive people out of their home because they can't tolerate some new-fangled technology? Her description of their precious home that had been set up with special varnish and paint and filters and then a corporation comes along with new tech that makes her daughter sick. I'm appalled! IS THIS WHAT 'WE THE PEOPLE' WANT? Do you understand why WE THE PEOPLE can no longer allow this?

<u>All</u> living beings/organisms are electrical in nature and are therefore affected by electrical fields, magnetic fields, and radio frequency. Our cells are electric. Our blood even has electric aspects to it. Our brain, our heart... Nature is electric so if it's affecting the humans, it's affecting everything! As for the idea that they are "NECESSARY to eliminate meter readers" it seems to me that I recall sending in a postage paid card monthly with the numbers of the meter for a decade while living rural. Again, if we can call in millions of votes for America's Got Talent contestants, I'm pretty certain it would be feasible to call them in on a phone system, or to report them via an internet-based system. A picture can even be taken and sent by email every 6 months as a form of audit.

**How my activities are limited:** I can't enter any buildings here so I can't shop, go out to eat, go in the post office or even the courthouse, to the hospital or ER, can't visit friends in their homes. I am effectively blocked from access to a dentist, a chiropractor, a massage therapist by these forced electric meters! I could ask other patients and providers to turn off their cell phone and WIFI, but I can't do anything with these electric meters here. I haven't left a restricted area here near our home since February of 2021 and as of September 2021 I no longer ride to the dump with Mom, due to two new towers south of town. I can't even ride from Hasty area to Western Grove due to a new tower that came in after arrival.

In Austin, TX, out my bedroom window was our neighbor's digital electric meter. Sadly, she was willing to change it until someone at PEC (Pedernales Electric Co-op) essentially told her "It's not the meter, it's the powerlines." Reportedly, PG&E is now being sued for their part in the California fires that burned out several towns because they knew they had a problem with their lines but failed to act. So, are we supposed to just believe every utility company or tower company who says "It's not us" or should they have to prove their meter, tower, or product is safe, tested in its true environment by a Citizen's Watchdog group? They should continually need to establish safety and face severe punitive actions for any issues? This is why you can see many networks on your phone or wireless devices available to you if you just knew their password. I enclosed a paper catalogue from **LessEMF.com** with the package sent to local overseers. It's a company who sells a lot of the safety products I used to create a safe computing space and a great learning tool. The first one I requested in late 2016 boasted on the front cover "Celebrating 20 Years", 26 years now! I couldn't help but wonder why the powers-that-be didn't feel compelled to tell consumers we needed to be using hardwire options, grounding, shielding, and filtering products on all these new tech gadgets if they've known for 26 years! Nope, they brought in MORE wireless and not one single commercial for warnings and public service information AND they pulled jurisdiction from every oversight agency, so they essentially sent all the sheriff's home so there's nobody to report the crime to and the rollout continues.

A single peanut, a little shellfish, or a bee sting can kill some people; we are not all the same. Those who have Multiple Chemical Sensitivity are also typically more "sensitive" to electrical current and mold. # Love Thy Neighbor?

There were 2 of us with this condition in this area when we moved here. A friend who does a lot of home repair and maintenance here now reports that he knows 8 people in the area with Electromagnetic Hypersensitivity. Another one rented a local cabin the very week we came to see/sign on the home purchase here according to a cabin rental owner. People are literally looking for escape from the electromagnetic smog in the cities. I already know of people living in metal sheds, and some in their cars because the saturation in their living environment has become intolerable. Three women I know have become homeless due to lack of suitable living options. Many pets are also having seizures and getting cancer most likely from what's known as "dirty electricity" or line noise coming into homes from these new-fangled electric meters being deployed all over the world. NoMoreTowersInTheOzarks.org aka TheTruthAboutTechnology.org has an Images That Teach category you should check out. You'll see several screenshots showing how people's pets responded to the installation of one of the electronic utility meters. Once you understand the nature of this, you'll understand we are all "sensitive" to electrical current and radiation, no matter how subtle. We are highly sensitive electrical beings with a subtle energy field that radiates out around us for at least 6 feet in every direction. Have you ever FELT anger on someone just standing behind them at the bank or in the grocery store and didn't understand why? You're feeling what's IN their energetic anatomy. You may feel JOY coming from someone too. We are energy beings in physical bodies so we're ALL being affected. It's a matter of not recognizing the source of the diseases related to 'CHRONIC EXPOSURE TO NON-IONIZING RADIATION'.

<u>THIS</u> has never been done in the history of humanity. There are no ancient metal towers with antennas and transmitters with microwave drums on them, and electrical appliances inserted into wiring system, so we better be measuring the outcome of these new choices we're accepting and make some changes, NOW!

Some neighbors recently reached out. They've lived here many years. Jim heard my story and a few months later his wife called asking if they could borrow my Stetzer meter as Jim wasn't "feeling well". I loaned them the Stetzerizer meter, and they found very high readings in their home. I loaned them a few \$30+ plug-in filters I bought online with instructions, and they reported an immediate improvement. Jim felt better and both were sleeping again and had been unable to do so for several months, since expanding his solar panel array. I saw him in town a few weeks later, after they too installed a SATIC filter on the electric panel like ours. With a very sincere look Jim said, "..., what I felt was not good. It felt very dark...". Ellen later used the word "agitated" to describe Jim's behavior, a man who is generally very happy and upbeat. He then went on to say, "Now I'm wondering if this has something to do with both neighbors by me getting a divorce." My reply, "Uh huh. You felt the same thing I felt on day 3 in the new house here."

I then spoke to another neighbor a few doors down. His wife just "basically sat down five (now 7) years ago and quit being a wife in every regard" shortly after the meter was installed. They are now divorced, and he was sporting a fresh scar down the front of his chest, describing open heart surgery. These meters affect the heart as you'll see in the Digital Electric Meters category of the "no more towers" site. I didn't take measurements in his home but did make the mistake of walking into a little cabin on the place. From a 1-minute exposure I can tell you that I expect I'd find very high readings there. It was a few hours later

before I no longer felt the effects. It should be investigated but has now changed owners who live out of town. I also met a shop owner on the downtown square who owns a business, and his living quarters is upstairs. He's 55 years old but has a \$180,000 pacemaker in his chest. He reported having two major heart attacks before this. The new electric meter was installed before these cardiac events occurred "out of nowhere".

Another downtown store owner, prior to Diamond Real Estate, reported that she'd begun having migraines. I was in her store about 15 seconds before I HAD TO flee. Talking to her neighbor about this he mentioned his opinion that he felt there was "something wrong with her because people would come out of her store crying". <u>THAT</u> is a "fight or flight" reaction triggered by non-ionizing radiation, EMF's, dirty electricity...radiation! Whatever name you call it, there was nothing wrong with her or the people who entered her store...it's the sick building wiring from these toxic utility meters forced on members of a member-owned cooperative corporation.

I loaned a meter and a plug-in filter to a woman who's a vendor at the Farmer's Market. She took it to their travel trailer and ended up putting one of the plug-in filters in an outlet and reporting that her "husband was nicer" and he was bobbing his head in agreement behind her. (Remember those divorcing couples?)

Then there's the little boy I met. He spent the first 3 1/2 years of his life in the hospital and now eats through a tube/machine. He's 10 now, which means he was in utero when these new electric meters were being deployed, and already at 55% coverage in 2012, his year of birth. I have not measured their home's outlet readings but if you want to see what DNA damage does to someone, look at precious little boy. The blueprint got messed up and that's what RADIATION does. We can call it "EMF's" and "Dirty Electricity", but we all recognize mutations from manmade radiation are a real thing. Look up the aftereffects of Chernobyl on YouTube. We are playing with things we don't understand as if we do! Keep in mind that I've only been here two years and have been very busy with our own efforts to settle in, so I really haven't had much time to meet many people. I can't imagine what my educated-to-the-issue eyes would see if I were to go looking but someone had better get up to speed and respond.

### The Battle for an Analog, mechanical only, non-transmitting, Electric Meter

First, sources for analog meters do exist even if the utility company says they don't! I have one here I bought online for installation when we win this illegal, immoral, battle. If there aren't enough available, then let's build them. If local people don't want to work, as is often stated here, I can assure you there are a lot of people who would LOVE to live in the Ozarks if they had a job. We don't have to go crazy with industry, just build analog meters and that's all.

For the record I have <u>not</u> found CECC (Carroll Electric Cooperative Corporation) to be kind, compassionate, lawful, or trustworthy which is one reason I'm taking next steps. Finding locals who tell zealously of them locking "members" out of public meetings and changing rules to control who gets on the board, and that the high-pitched squeal started right after they began installing these new meters, along with the few years of reading and hearing of other people's experiences with these lawless entities leads me to distrust them. Early emails indicated that they weren't going to be an exception. I am not qualified to know if I'm being bamboozled by them, so I didn't take them up on their offer to bring their meters and check the inside and outside. And the ADA (American Disability Act) even states that I don't have to have any conversation with someone about the validity of my condition. Certainly, if this is a "new" thing happening to people there's a very good likelihood that the "ignorance of the able bodied" could thwart

justice and compassion. Those are the actual words in the ADA Amendments of 2008, "ignorance of the able bodied" in reference to preventing the disabled from being accommodated. She doesn't understand my disability and it's not my job to educate her. BTW: There was barely anything plugged in here when I found the dangerous readings in this house as we had just moved in. I spent 17 days in the RV and couldn't come in the home unless the main breaker was turned off. I owned a few of my own meters and the one measuring what's coming inside through the electric outlets is so simple a six-year-old can do it. Then, the rest of the story began unfolding with our too young to die ladies dropping dead every December.

I'm convinced, as many people are, that our electrical habits indoors were much more forgiving before they began putting these new meters in place; "stepping down" 220 volts to 4-10 volts with their "DEVICE". What could possibly go wrong? These are not people I expect to show up in a good faith effort to help and I frankly didn't want them on our property after I suspected them of giving false information about how many times a day the meters transmit, and other predictable behavior being seen by many of us who share this mission to right this wrong. As well, I presented a "Letter of Medical Necessity" from my treating physician, who's a University of Texas graduate MD, Functional Medicine trained and has attended EMF Medical Conferences. She's not some hairy legged naturopath girlfriend who works from her home just doing me a favor. Her letter gave my status as her patient, my EHS diagnosis, and that I could not have this form of electric meter in my environment. The staff attorney for CECC in Berryville, Arkansas wrote in response asking if my doctor was also an electrician and if so, she'd like to see her credentials. She also asked how my doctor is supposed to predict my reaction to a meter she's never seen or tested. She then downgraded my treating physician's diagnosis to a "mere medical opinion" and has yet to address the high readings being found all over this town, or the deaths in those toxic buildings. They also didn't send Randy Hooten or anyone else to investigate when that Chief Inspector in Little Rock, Arkansas asked them twice to do so. Two further inquiries about the country of origin for all components inside the meter were met with incomplete answers and a "you ask too many questions" letter. So, I bought one of the meters on eBay, took it apart and chased down components inside online. Sure enough I found what I think is a capacitor and the country of origin is China. The company made a strong effort to appear "American" as there are NO foreign letters on the product. I have a picture around here somewhere.

It seemed to me like she took the position that I needed to prove to her that I have this condition and instead of writing my doctor with her questions as the letter instructed, she seemed to take pleasure in writing me a hostile response. She's a lawyer, not a doctor and would have an obvious biased input in this situation. Would she want me to get up from a wheelchair to prove I can't walk? Again, is this how WE THE PEOPLE want to treat people who have become disabled by the hordes of new technology and in ignore-ance of the WHO diagnostic code? Is this the way we're going to regard others now? What about The Golden Rule, "Do unto others as you would have done unto you". Certainly, if we're having a "worldwide epidemic" as the NIH link above shows I think it's reasonable to accommodate those who are suffering from human corruption and ignorance. When we know better, we do better. IT IS TIME to do better. The following link gives ADA information but WE THE PEOPLE are going to have to FORCE some changes. One employee of Carroll Electric, now retired, wrote me, "This is better for everyone." Really? Is it better to just move the effects of new technology unleashed on the world off the discussion table? Is it better if we then further disregard the people disabled by said technologies? Is it better if we just ignore the 24/7 high-pitched squeal, dangerous readings, and the 70-year-old Chief Electrical Inspector in Little Rock proclaiming boldly "there's a problem up there" twice now? How about the CWD and the

absence of the bees? Exactly who is this better for? Is it better for the children and pets in these homes? I'm a paraplegic asking for a ramp! I'm a voice for those who can't speak or don't know what's happening to them and those they love. One local woman, 34-years-old said, "I've been on this mountain my whole life and I've watched people becoming sickly in recent years." Is this truly "better for everyone" Nancy or just for Carroll Electric?

When I wrote the Arkansas Public Service Commission a detailed letter with 20 links showing the dangers of these meters, details of my disability and the Letter of Necessity from my doctor, I quickly received a reply that clearly indicated the letter wasn't even read and the links weren't considered. Here is their reply:

"This email is to let you know that I am in receipt of your written complaint against Carroll Electric. The Arkansas Public Service Commission does not require the companies it regulates to provide an opt-out for AMI metering. The company is not in violation of the Arkansas Public Service Commission's General Service Rules, by not allowing you to use an older version of metering equipment."

And yet, I can move one county over and use a different energy company, also overseen by the Arkansas Public Service Commission, and I can get an analog meter. Seems like these corporations basically can do whatever they want. In fact, an energy company in Corpus Christi, TX where there's and "Opt-Out Law" told a friend who tried to Opt-Out of the electronic meter and exercise her legal right to have an analog meter and they replied, "That's not our policy". So, they essentially said, "It's not our policy to follow unfavorable to the corporation laws! And when we made phone calls to energy companies, you'd be shocked how much ignorance there is about who requires these meters. Several answering phones think the PSC REQUIRES these electronic utility meters but that can't be true, or every utility provider would be REQUIRING THEM. Too many irregularities. Too much ignorance. I recently learned that one classroom at a local middle school has "dirty electricity" readings up to 1600, (should be 30), plus they have WIFI routers cooking the children and staff. I'm expecting this is "the norm" so let's get some meters, filters, and hardwired ethernet stations going!

#### THEN, this happened December 27th, 2021:

#### Dish and DirecTV

After this letter went out something else happened that you NEED to know. We installed a pricey but necessary SATIC filter on our electric panel and also have a few Greenwave plug-ins throughout the house to tame the insanity coming from these electric meters being used here. This was done immediately upon move in. All computers are grounded and shielded, and all screens have anti-blue light filters. There is no WIFI, no cell signal, and no cordless anything! We live in a steel-skinned home, so all voltage/current tends to stay inside with us. As an electrosensitive person, this means that running a vacuum in here feels like current ricocheting off the walls and hitting me, so I use a battery-operated sweeper. My point is that my environment is safe, and I know it's safe because I can feel when/if something changes.

On December 27, 2021, I was cooking dinner, waiting for my niece to arrive when some new current came screaming into this house that felt like I was being electrocuted. I ran upstairs and grabbed the new meter from supporter donations and ran down screwing the big antenna into place as she drove up. She's a smart cookie who had a high school diploma and a 4-year degree at 18 years old. She's a captain in the Air Force now and we'd had a recent conversation about the FAA's concern over the deployment of 5G around airports. In their petition to stop it they stated that Dish and DirecTV would be moved to the C band part of the electromagnetic spectrum and would be the only things parked there. She gave a hard eye roll and stated her beliefs about why it shouldn't matter and that was it, but I didn't forget what I'd read in that FAA petition either about Dish or DirecTV so I knew to at least expect that something could change in my/our environment.

My niece was pulling up as I ran out the door and handed her the meter asking her to "go in and point this meter around the room and see if you can find the source...". She came out in a few minutes and said, "It's coming from the TV." The reading exceeded the limits of the meter, which is 2.45 GHz, meaning we have no idea of the true reading, but it was HIGH and therefore DANGEROUS! I had her unplug The Dish equipment and the television and we enjoyed our weekend visit.

The next week, I waited a few days before plugging up the Dish equipment and our tv to allow for any issues to settle out. I had noted when electricians came to heal our house that often it would take 3 days for things to calm completely. I took some readings again with the same meter and there was now a 2.6 mw/m2 reading in the house that had not been here before or I would've felt it. Readings in my mom's room, which is surrounded in metal on 3 sides were showing the signal bouncing wall to wall. I knew this wasn't okay as a safe reading on this meter is .1 according to Building Biology standards. Some experts say they're okay with a 5 reading but again, in this steel house where everything electrical is amplified and trapped in here with us, and me having EHS, I have a lower threshold of what I'm willing to tolerate, especially if something suddenly changes.

I again unplugged their equipment, and we began the search for television that didn't involve being cooked. We now have a hardwired to the internet television and LOVE IT. It's a TCL brand, their 4K series and I have another book here that shows an adaptor so we can use the existing coaxial cable to use this same set up in other rooms if we buy the right kind of television. We were now safe again but then...our precious neighbor, 82-years-old, had a stroke. I was talking to God one day about him and wondered if there was anything in his electrical world that could explain this. Bam, it dawned on me that he too has Dish satellite tv and lives in a metal house though it's covered by vinyl siding. I took the big meter with the Christmas tree antenna and showed his daughter how to use it. Keeping it brief, but the same thing happened. It exceeded the meter's limits. Meters are now necessary tools for the electrified world we live in.

Also, can we please stop spraying WIFI (245 billion cycles per second of Pulsed Microwave Radiation) out into this dense natural forest at the Library and the Courthouse and anywhere else now that we should know better? PLEASE! These are not private businesses, and this shouldn't be happening now that we know what we're really doing. Instead, let's build a tourist-friendly cabin at the library with several hardwired stations and lots of literature about how to use technology safely.



The staff attorney wrote snidely asking if my doctor "was an electrician and how she'd know about an electric meter she'd never seen" which is a huge violation of ADA laws and violates God's moral code for treating someone the way you want to be treated. BTW: The answer to her questions is because this doctor had taken courses on the hazards of electromagnetic fields, sources of same, and how it may affect a patient. There are tons of scientific studies on it now not to mention the ease of access of information on the internet alone, like where most of the info in this booklet came from. Go to PubMed and look up "Electromagnetic Fields" and see where it takes you. She then took liberty to downgrade my examining and treating doctor's diagnosis to a "mere medical opinion" which may be true when a person hasn't been examined or seen but that's not the case here and she/you/we can't just disregard a qualified medical doctor in favor of a utility corporate lawyer. Do you see where this kind of behavior being tolerated can facilitate evil ideas? Since when did "we the people" become the scrutinized and the corporation become protected? Again, are you okay with this because it's only a matter of degrees between having a corporation FORCE technology onto your property for essential services to the point of a corporation being allowed to FORCE technology INTO YOUR PERSON if you want to have essentials to living? Can you see why resistance may be an important stance at this juncture?

I had asked for a mechanical analog utility meter and offered to take a picture and email my readings to CECC or even phone them in. I then reached out to DisabilityRightsAR.org by phone and spoke to Thomas Nichols, the legal director. I told him the situation and when I emailed him the written response of their staff attorney, he told me that my request for accommodation and offer of remedy was "perfectly reasonable" which is legal language. He advised me to file a complaint with the Arkansas Fair Housing Administration. While doing so, a man named Darryl said, "Well if you have a letter from a doctor, that's what our decision will be made on." A week later I got a letter from that agency saying, "We have no jurisdiction in this matter" and the case was sent to the Department of Justice. A few weeks later I received a letter from the DOJ saying they "have no jurisdiction". The case was then sent to Legal Aid and in my opinion the subject matter was above the head of the person who got the case so again....no relief. I don't know why I'm supposed to take the word of someone who researched it for a few days instead of ME who'd been at it for several years at that point but that's the world we live in now. I then wrote an EMF email group and asked about their experiences where they shared that a dozen of them had gone through the same process. Their cases had sat with the Dept of Justice for 2 years when suddenly all twelve of them received a letter saying, "We no longer have jurisdiction". So, essentially, the powers-that-be pulled oversight or "jurisdiction" regarding wireless or tech issues from every agency that could bring relief or hold offenders accountable. If you send all the sheriff's home, there's nobody to report the crime to. I tell you this because I want you to understand when I share this next step that I came to this after exhausting every other avenue.

At a certain point, the saturation and lowering of towers made it clear that this is not about us being able to use our cell phones so getting rid of as many towers and antennas as possible is a next step. Go to the Images That Teach page and see what you learn. Buy the Hidden Dangers book.

Simple enough, if you need to use a wireless device, you simply walk away from people and remove it from its bag. You no longer get to "smoke" anywhere you want without regard for others. You wouldn't hand your child a lit cigarette to smoke so they shouldn't have a cell phone in their hands either. # First Option: The CRIMINAL ASSAULT Complaint Process

A "barrister" aka a "lawyer" in Australia, Ray Broomhall, had a client presented to him by one of their agencies who has Electromagnetic Hypersensitivity. Ray Broomhall commented on the US Criminal Code in the USA and believes this method applies here. My own research indicates that in the USA you have to establish that the assault is intentional. I'm pretty certain that it was in an early release of <u>Cal Washington's Notice of Imminent Liability Effort</u> below, that after you've informed the person or entity that you are being harmed by their behavior, if they do not cease immediately, then it becomes intentional with a daily fine levied. I would give or send the assailant or emitter a copy of this booklet and document that they received it by certified mail or a witness and photo of them being handed the booklet. For "intentional" assault it looks like a serious prison term can apply.

"This document causes that person to be personally responsible to pay all costs of harm and damages caused by the unlawful invasive radiation-emitting fire hazard surveillance device they have put on the side of your home after you show them evidence of damage and submit your claim.

"We have found that utility companies usually do not properly or lawfully respond to a customer's refusal of the hazardous and harmful electronic utility meters. Rather than simply provide a standard, safe and lawful electromechanical meter as the law requires, the utility company usually proceeds to unlawfully bully, harass, mislead and penalize the customer, and in some cases terminate the customer's electric service unjustly.

"Our courts, justice system and law enforcement consistently fail to protect utility customers from this abuse and these criminal violations perpetrated by utility company officers and employees.



I've met Steve and Rockie Richards in the Austin area who were trained by EMF Experts.
