A **Common Law Commercial Lien** is a process that any Human Being can employ in order to obtain lawful remedy from the actions of another Human Being(s) who have – or have attempted to – or have conspired to - damage said Human(s) in some way. Such wrongs are known as “torts”, and are the subject of Tort Law.

The reason for this is very simple: Since all are equal under the LAW, then each Human Being has a Duty of Care to each other Human Being, such as to make sure that – whatever action we take towards each other – we have the Common Law behind those actions, and thus can live together in peace.

Abrogating said Duty of Care is a **CRIMINAL ACT**, and constitutes a tort.

The affiant is not a lawyer and her pleading cannot be treated as such. In fact, according to *Haines v. Kerner*, 404 U.S. 519 (1972), a complaint, "however inartfully pleaded," must be held to "less stringent standards than formal pleadings drafted by lawyers" and can only be dismissed for failure to state a claim if it appears "beyond doubt that the plaintiff can prove no set of facts in support of his claim which would entitle him to relief." Id., at 520-521, quoting *Conley v. Gibson*, 355 U.S. 41, 45-46 (1957).

“Indeed, no more than affidavit is necessary to make a *prima facie* case.” *See United States v. Kis*, 658 F. 2nd, 526, 536 (7th Cir. 1981): *Cert Denied*, 50 U.S.L.W. 2169; S. Ct. March 22, 1982.

PRIVATE ATTORNEY GENERAL

According to the Civil Rights Act of 1866, 14 Stat. 27, enacted April 9, 1866, (and sometimes referred to as The Private Attorney General Act), 39th Congress, Session 1, Ch 31 (1866), CHAP. XXXL, (Formally titled): An Act to “Protect all Persons in the United States in their Civil Rights, and Furnish the Means of their Vindication,” April 9, 1866; Public Law 104-317, Oct 19, 1996, 110 Stat 3853; 93 stat 1284; Public Law 96-170, 96th Congress, Dec 9th 1979.4:

“Private attorney general is an informal term usually used today in the United States to refer to a private party who brings a lawsuit considered to be in the public interest, i.e., benefiting the general public and not just the plaintiff. The person considered “private attorney general” is entitled to recover attorney’s fees if he or she prevails. The rationale behind this principle is to provide extra incentive to private citizens to pursue suits that may be of benefit to society at large.”

The private attorney general, made its first appearance in the legal literature in a 1943 decision, by Judge Jerome Frank, in the U.S. Court of Appeals for the Second Circuit. *See Assoc. Indus. of New York v. Ickes*, 134 F.2d 694, 704 (2d Cir. 1943). Judge Frank concluded that Congress could authorize a private citizen to file suit even if the sole purpose of the case were to vindicate the public interest as opposed to some private interest of the litigant: “*Such persons, so authorized, are, so to speak, private Attorney Generals.*”

In drawing this conclusion, Judge Frank analogized this citizen suit to a qui tam action. *Id. at 704-705* discussing *U.S. ex rel. Marcus v. Hess*, 317 U.S. 537 (1942); and also *Colorado Radio Corp. v. F.C.C.*, 118 F.2d 24, 28 (D.C. Cir. 1941) (Edgerton, J., concurring).

The plaintiff holds the position as a private Attorney General, under the 1866 Vindication and Civil Rights of the 39th Congress. This Congressional Act gives the Plaintiff the authority to step in, when the states fail or the government fails to uphold and protect the rights of the citizens. It allows the plaintiff to act as a prosecutor, and enable him to bring charges on those who hold public office and hold them accountable for their misdeeds and misconduct, in breach of their trustee duties as fiduciaries; as is written in the *Lieber Code, Under General Orders No. 100*. This includes insurrection and rebellion, and misuses of their/that public office in order to abuse and to incite riot among the peaceful inhabitants, as well as endanger the lives and health of United States Citizens.

The Maricopa County Health Code is adopted under authority vested in the Maricopa County Board of Health and the Maricopa County Board of Supervisors pursuant to the Arizona Revised Statutes § 36-136, 36-183.02, 36-601, 36-184.B4, 36-187.C, 11-251 paragraphs 17 and 31, 49-106, and 49-107.

STATEMENT OF CASE IN FACT

[Made Pursuant to Title 28 USCA Section 1746]

COMES NOW, the Affiant/Petitioner/Secured Party Creditor/Authorized Representative, Private Attorney General, Coralyn Hill, deposes as follows under oath:

That the State of Arizona, The Maricopa County Board of Health, Maricopa County Board of Supervisors, Maricopa County Environmental Services Department, Maricopa County Vector Control, and The City of Gilbert, are currently, and have been, committing the following crimes, while acting under the Color of State Law.

- 1. MICROWAVE AND GWEN TOWERS** – That all cities in Maricopa County, as well as around the United States, are constructing and maintaining Microwave and Ground Wave Emergency Network (GWEN) Towers on school grounds and in residential areas. There are one or more of these towers on every school campus in the Phoenix Valley, every $\frac{1}{2}$ mile on every major freeway, and in all outlying areas in and around the State of Arizona. The plaintiff will show that these are in fact NOT cellular towers, and the effects of cellular towers are completely irrelevant in regards to this matter.

Plaintiff will prove that these towers are NOT cellular towers, and if the defendant denies that they are in fact Microwave and GWEN towers, then he must provide proof of exactly what type of towers these are, what their intended purpose is, and must show that they are not harmful to human beings and wildlife. This is impossible to accomplish, but I welcome the effort.

- 2. VECTOR SPRAYING** – That Maricopa County Vector Control is spraying our neighborhoods, parks and wildlife preserves with chemicals that are highly toxic to human beings, domestic and wild animals, birds, fish, aquatic life, and fatal to bees. The plaintiff will prove, using the county's own literature, government issued material data sheets, and independent toxicology data, that this is taking place on a routine basis in Maricopa County, and in fact, in most all counties within the United States of America.

- If an individual did this to another individual, he would be charged with attempted murder, for intentionally poisoning another human being.**

If an individual did this to a group of people, he would be charged with mass murder and possibly even labeled a Serial Killer.

So is it not a crime when a group of people intentionally poison another group of innocent people, openly and publicly, year after year? That is absurd.

- 3. WATER FLUORIDATION** – That the municipalities are dumping Sodium Fluoride in the public drinking water. Sodium Fluoride is a hazardous-waste by-product from the manufacture of aluminum. It is a common ingredient in rat and cockroach poisons, anesthetics, hypnotics, psychiatric drugs, and military nerve gas. It is also one of the basic ingredients in both PROZAC (FLUoxetene Hydrochloride) and Sarin nerve gas (Isopropyl-Methyl-Phosphoryl FLUoride). To claim that it is beneficial to the public in any way is once again, absurd.

4. **AEROSOL GEOENGINEERING** – That Chemical and Nanoparticles are being disbursed into our skies and into the air we breathe, using several different disbursement methods, and the defendants are all assisting with, and/or ignoring this heinous crime. MICROWAVE TOWERS

There are several different types of towers and antennas that have popped up around the world in the past few years. Cellular towers used for communication must be registered with the FCC. Many cellular towers are no longer “active.” They are still owned by the cell company, but have been leased out by the feds and converted to other types of towers, namely Microwave.

Antennas, have both Transmit and Receive capabilities, and are also showing up in the microwave spectra.

Since the Federal Govt. has taken control of most cell phone companies (ATT, Verizon, Cingular, etc), they have managed to keep most of their leased towers/antennas off the record for unknown reasons. But if they were being used as communication devices, they would have to be in the FCC Database, which they are not. Also, if they were “cellular”, they will be listed as such in this database, as either private or commercial. But they are NOT.

Though there is a lot of data on the negative effects of cellular towers, I am not interested in those at this time. What I am concerned about are the microwave towers. Since they are not registered with the FCC, they are not used for communication. So what is their purpose? There are only a few answers to this question, and none of them are pretty.

The following is an FCC Database search for the City of Gilbert. Notice that most of these filings have either been **terminated** or **cancelled**. This means that they are NOT being used for communication purposes, and have been converted for some other use. Others you will see classified as **granted** and **operational**. These ARE in fact, communication towers.

Note: Almost every school campus has a tower on the premises. None of those towers are registered with the FCC, which means that they are not cell towers, and most are of type “Microwave.” This is my main concern, and it should be no different for any parent with children in school.



Antenna/Tower Search

A search was then run using www.antennasearch.com, for all towers and antennas within a 4 mile radius of my home in Gilbert, with no regard to the FCC. In this database, “registered” can mean two things: All towers over a certain height must be registered with the FAA, for obvious reasons. So the word “registration” can refer to FAA, or the FCC. This gives a visual image of the tower, and the Service Type, which in these cases is “microwave”

Out of the hundreds of towers and antennas within a four mile radius, I pulled only the **Microwave** structures and mapped the locations below.

The following are details for each of these microwave towers:

Note:

- Just because a Cell phone company owns it that does NOT mean it is being used for cellular communication.
- Towers are “Registered” due to their Height. This is not an FCC Registration, but merely for FAA purposes.

Only a few of the structure details have been included in this document as examples. All towers on the map above are in fact, Microwave.

Microwave Sickness

Many people have a hard time fathoming that something that they cannot see, touch, smell, taste or hear - sense with the five senses - can harm them so much.

If you put a frog in boiling water, it will jump out. However, if you put a frog in cold water and gradually heat the water, you can cook the frog because the frog's body will adjust to the slight changes in temperature and it will not notice it is being cooked. Well, the same thing is happening to an unsuspecting public - a public that has not been informed about the real dangers of microwave radiation.

1. Symptoms known to be caused by exposure to microwave radiation: insomnia and other sleep disturbances, headaches, swollen lymph nodes, depression, anxiety, loss of appetite, hypoxia (lack of oxygen getting to your tissues), inability to concentrate, forgetfulness, dizziness, irritability, nausea, hyperactivity, fatigue, vision problems, dry eyes, eye inflammation, weakened immune system, allergies, frequent urination, night sweats, extreme thirst, etc. These symptoms very often suddenly appear in people who have had a cell phone tower installed nearby their home.
2. Microwave exposure induces Oxidative Damage leading to depletion of the body's natural store of antioxidants like Super Oxide Dimutase (SOD), Catalase, Glutathione, CoQ10, and Melatonin. When the body becomes depleted in antioxidants, premature aging, increased infections, and sticky blood are just a few of the consequences. With a depressed level of antioxidants in the blood, for example, high-density lipoproteins (HDL) or the good cholesterol will bind with free radicals (oxidants) turning the good cholesterol into bad cholesterol or low-density lipoproteins (LDL). This leads to more viscous blood which in turn can lead to blood clots leading to strokes and even heart attacks.
3. Microwaves have been known to affect an abnormal influx of calcium into cells. When there is an abnormal influx of calcium into mast cells, for example, they produce histamine. This is just one of the ways in which microwave exposure has been known to trigger or aggravate allergic reactions.
4. Microwave exposure has been known to induce mitochondria dysfunction. The mitochondria are the powerhouse of the cell. Dysfunctional mitochondria will interfere with the cells' ability to produce energy and can be linked to fatigue and possibly even obesity.
5. Microwaves have been shown to depolarize the body's red blood cells. This will cause the red blood cells to clump together and when this happens, the amount of oxygen getting to the brain cells and the cells of the body's other organs is diminished substantially leading to hypoxia. This can cause symptoms similar to altitude sickness: nausea, dizziness, inability to concentrate, and so on.
6. Microwave exposure has been shown in studies to induce a decrease in the numbers of Natural Killer (NK) cells, a form of white blood cell which is the body's first line of defense against pathogens. This leads to the body's weakened ability to recover from viral and other types of infections. Therefore, people exposed to microwave radiation would take longer than normal to recover from your day-to-day infections.

7. Exposure to long-term microwave radiation has been shown to change a particular form of white blood cell (lymphocyte) ratio - known as the T-helper/T-suppressor (T4/T8) cell ratio - from normal to abnormal. Abnormalities in this T-lymphocyte ratio have been shown to lead to an increased susceptibility to viral, fungal, and bacterial infections. Symptoms include sore throats, low-grade fevers, weakness, persistent fatigue, and swollen lymph glands.

8. In fact, research has shown that exposure to microwaves and other electromagnetic radiation has been shown to increase viruses, bacteria, mold, parasites, and yeast in the blood of the human host.

9. Microwave exposure has been shown in studies to induce what is known as "subliminal" stress (since the body does not know it is being stressed) causing the adrenal glands to excrete an abnormally greater amount of cortisol and adrenaline. Excretion of adrenaline, for one, can lead to irritability and a feeling of hyperactivity - the latter now very common in children with Attention Deficit Hyperactivity Disorder (ADHD). In a continuous state this will eventually lead to adrenal exhaustion, in which the adrenal glands just stop working.

10. Microwave exposure has been shown to cause a decrease of 5-HT in the blood. 5-HT is a precursor to the production of the brain hormone serotonin. Low levels of serotonin have been linked to anxiety and depression. An increase in anxiety and depression can in turn be linked to an increase in the number of suicides.

11. Microwave exposure has been shown to induce a decrease in levels of the brain hormone norepinephrine. This hormone is essential for control of the autonomic nervous system, and lack of it can lead to autonomic nervous system disorders. For example, if the autonomic nervous system is not working properly, the body will have trouble regulating its temperature - i.e. cooling itself when it is warm and heating itself when it is cold. This could lead to feeling colder than one would normally when it is cold and feeling warmer than one would normally when it is warm. An abnormal decrease in norepinephrine levels has also been connected to short-term memory disturbances and depression.

12. Production of the brain hormone melatonin has also been shown to be altered by exposure to microwaves. This brain hormone and antioxidant is necessary for proper sleep. 42 million (approximately one in five) Americans now take sleep medication for insomnia while others often experience sleep disturbances due to exposure to electromagnetic radiation (EMR). A drop in melatonin levels has also been connected with increases in breast cancer.

13. A drop in the levels of the brain hormone, dopamine, has also been shown to be connected with microwave radiation exposure. A drop in dopamine levels has been linked with depression.

14. Exposure to electromagnetic radiation has been shown to effect an abnormal drop in the levels of the neurotransmitter acetylcholine. A drop in the levels of this neurotransmitter has been linked to a number of neurological and neuromuscular disorders - including Alzheimer's disease.

15. Some electromagnetic frequencies have been shown to induce restlessness and hence may very well also be responsible for a syndrome called restless leg syndrome (RLS).

16. Electromagnetic fields - have been shown to alter regional cerebral blood flow. In conditions like autism and chronic fatigue syndrome (CFS) it has been shown via SPECT (Single Proton Emission Computed Tomography) scans that there is a decreased flow of blood to the brain.

17. Microwave exposure has also been shown to adversely affect the heart and could very well be linked to heart irregularities and responsible for triggering heart attacks.

18. Numerous studies have connected microwave and other electromagnetic radiation exposure to an increase in allergies. Microwave exposure has been shown to turn on mast cells to produce more histamine - the chemical responsible for allergic reactions - and other electromagnetic fields have been shown to actually increase the number of mast cells in the body. Microwaves have also been found to increase Immunoglobulin antibodies in the body. Immunoglobulin antibodies are responsible for triggering an allergic reaction to a particular substance or protein. Many researchers and scientists were - and still are - puzzled by the fact that the East German population had so few allergies in comparison to the West German population when the two countries unified. But what they failed to examine is the simple fact that East Germany had much stricter regulations regarding ambient radiation levels than West Germany. Since East Germany adopted West Germany's standards, allergies in former East Germany have since reached par with the levels of former West Germany.

19. Exposure to microwave radiation has also been shown to affect an abnormal increase in nitric oxide (NO). One theory holds that an abnormal increase in cellular calcium will also lead to an abnormal increase in cellular NO, which in excess produces a damage-producing free radical or oxidant called Peroxynitrite.

20. Microwave exposure has been shown to open the blood brain barrier (BBB). The BBB protects the brain from foreign substances like viruses, bacteria, and chemical toxins in the blood which may injure the brain. Thus, exposure to microwave radiation could very well open people up to viral and bacterial infections of the brain which they would not normally get otherwise.

21. There has been a drastic increase in brain tumors and other cancers - not to mention diseases such as autism, ADHD, Chronic Fatigue Immune Deficiency Syndrome, and Alzheimer's - with the advent of the cell phone. Especially, after 1984 (the year the first cellular phone networks were set up in most major cities in the USA) there was a notable jump in children's brain tumors according to the National Cancer Institute (NCI). Brain tumors are now the number two cause of death in children followed by leukemia. Just last year seven people in Melbourne at RMIT University working in a building on the top two floors underneath these towers were suddenly diagnosed with brain tumors. There has also continuously been an exponential increase in autism since the advent and increase in numbers worldwide of these towers.

22. There have been numerous confirmed cases of deformities in animals and plants near microwave towers. Now, in heavily electropolluted Japan it is very common for women to have miscarriages in their last trimester of pregnancy. Usually, the fetus is deformed. Microwave has also recently been shown to lower sperm count in men).

There is no excuse for these towers to be in the middle of our children's schools. This a blatant disregard for our children's health, and the school districts are selling out our kids for money. Also, is the money that the school districts are receiving from the Federal Government a matter of public record? I.E. is it on the books? Is it going towards books and being put back into the classrooms?

The summer monsoons bring rain that we need but the mosquitoes also need it for breeding. Mosquitoes can lay eggs in tree holes and containers such as old tires, buckets, toys, potted plant trays and saucers, bird baths, fountains, wading pools, pet water dishes, plastic covers or tarps, or any other thing that can hold water. It only takes 3 days for mosquitoes to transform from eggs to "biting" adults.

You can help fight mosquitoes by eliminating their breeding grounds.

- Empty standing water from containers after each rain event
- Check and eliminate places that accumulate water after irrigating your yard
- Keep fountains operating or drain the water
- Keep swimming pools treated and circulating
- Repair leaky pipes and outside faucets
- Check air conditioning drain hoses to ensure water is not pooling
- Replace your outdoor lights with yellow "bug lights"

Who is responsible for mosquito control?

The best way to eliminate mosquitoes is to eliminate their breeding sites. Residents, businesses, homeowner's associations, and municipalities are all responsible for eliminating and preventing mosquito breeding on property they own, occupy, or are responsible for maintaining.

The Town of Gilbert's mosquito control program oversees the treatment and elimination of mosquito breeding areas only at its municipal parks, facilities, groundwater recharge and wildlife habitats, and Town operated retention basin areas. The Town provides fogging and larvacide treatment applications in these areas only twice per week, from **April 1st through October 31st** annually. The fogging operations take place during night time hours by certified technicians using a product that is safe around humans and animals.

On those evenings that wind or rain prohibits fogging at the Town's designated treatment areas, the contractor will retry the next evening. If the weather is prohibitive again on that night, the contractor will resume on the next normally scheduled evening.

- The Town of Gilbert is striving to improve the effectiveness of our fogging. To reduce the potential for chemical resistance in mosquitos, Gilbert's contractor will alternate fogging between EPA approved Fyfanon ULV and Kontrol 4-4.

However storage at too high temperatures may induce formation of the much more toxic and synergistic contaminant isomalathion (LD₅₀, acute oral, rat = 89 mg/kg). Malathion and isomalathion can affect you when breathed in and can cause organophosphorous poisoning. Symptoms of poisoning may include headache, nausea, vomiting, blurred vision, tightness in chest, drooling, frothing of mouth and nose, convulsions, coma and death.

Skin contact: Direct skin contact may cause slight irritation. Malathion and isomalathion can be rapidly absorbed through all skin surfaces. Causes symptoms similar to those listed for inhalation.

Eye contact: Direct eye contact causes irritation. Malathion and isomalathion can be rapidly absorbed through all skin and eye surfaces. Causes symptoms similar to those listed for inhalation.

Ingestion: Malathion and isomalathion are poisons through ingestion. Causes symptoms similar to those listed for inhalation.

Effects of long-term (chronic) exposure: Prolonged or repeated overexposure may cause behavioural changes.

Carcinogenicity: See TOXICOLOGICAL INFORMATION (Section 11).

Other important hazards: Cholinesterase inhibitor. May cause Central Nervous System depression. May cause damage to the peripheral nervous system. See TOXICOLOGICAL INFORMATION (Section 11).

Toxic Substances Portal - Malathion

5. Malathion stays in the environment from a few days to several months.
6. In air, Malathion is broken down by reacting with other chemicals formed naturally in the air by sunlight, to form a more toxic product called Malaoxon.
7. Malathion continuously breaks down to Malaoxon for several weeks after aerial disbursement when sprayed **in areas with high temperatures and extreme sunlight**.
8. **Malaoxon** exposure causes miosis, frontal headache, increased bronchial secretion, nausea, vomiting, sweating, abdominal cramps, diarrhea, lacrimation, increased salivation, bradycardia, cyanosis and muscular twitching of the eyelids, tongue, face and neck, possibly progressing to convulsions.
9. **Other symptoms of Malaoxon** exposure include hyperemia of the conjunctiva, dimness of vision, rhinorrhea, bronchoconstriction, cough, fasciculation, anorexia, incontinence, eye changes, weakness, dyspnea, bronchospasm, hypotension or hypertension due to asphyxia, restlessness, anxiety, dizziness, drowsiness, tremor, ataxia, depression, confusion, neuropathy, coma and death from depression of respiratory or cardiovascular systems. Exposure to this type of compound may result in giddiness, nervousness, blurred vision, discomfort (tightness) in chest, papilledema, muscular weakness, loss of reflexes, loss of sphincter control, cardiac arrhythmias, various degrees of heart block and cardiac arrest. It may also result in spasm of accommodation, aching pain in and about the eye, nystagmus, delayed distal axonopathy and paresthesias and paralysis of limbs. A decrease in blood pressure may occur. Respiratory failure may also occur..
10. **Exposure to Malathion may cause severe poisoning or death.** Persons may be exposed to dangerous amounts if they go into fields too soon after spraying. The people most likely to be exposed to Malathion should be protected by wearing special clothing and breathing equipment. The area that has been sprayed should be avoided for at least 6 days.
11. It can also enter your body if you breathe air containing Malathion during or within 6 days after it has been sprayed for public health uses. By any means of exposure, Malathion enters your body quickly and passes into the bloodstream. Once in your bloodstream, Malathion can damage many organs and tissues.
12. Malathion interferes with the **normal function of the nervous system**.
13. Exposure to Malathion in the air, water, or food may cause difficulty breathing, chest tightness, vomiting, cramps, diarrhea, watery eyes, blurred vision, salivation, sweating, headaches, dizziness, loss of consciousness, and death.
14. Malathion can cause adverse developmental effects in the unborn, but only when the health of the mother is affected. A study of people in California found that the use of pesticides, Malathion among them, at home during pregnancy showed an increase of brain tumors in

children.

15. Families should be aware that sometimes Malathion could be illegally sprayed near the home to kill insects. Your children may be exposed to Malathion if either you or another person applies pesticides containing it near your home. **In some cases, the improper use of pesticides not intended for use near homes has turned homes into hazardous waste sites.**

GILBERT, AZ (CBS5) - Two top city administrators have been put on leave in Gilbert after officials discovered fluoride has been withheld from part of the town's water supply for at least the past 13 months.

Public Works Director Lonnie Frost and Water Manager Chris Ochs are on paid leave while the town investigates how and why fluoride wasn't being added at Gilbert's North Water Treatment Plant.

"We are taking this very seriously, but it's not a matter of a public health hazard in that the water was being over-fluoridated; the fluoride was not added," said town spokeswoman Dana Berchman.

"There is a natural level of fluoride in the water and there is nothing that is less safe because of the lack of fluoride," Berchman said.

She said an independent verification of all aspects of the city's system is being conducted.

"We are taking every step to remedy this situation and make sure it cannot and does not happen again," Berchman said.

According to the [city's website](#), the North Water Treatment Plant can produce as much as 45 million gallons of water per day and has a 16 million gallon reservoir on-site for water storage.

Many truly independent (unattached to any vested-interest) scientists who've spent a large portion of their lives studying and working with this subject have been subjected to a surprising amount of uncalled-for and unfair character assassination from strong vested-interest groups who profit from the public's ignorance as well as from their illnesses. History of Water Fluoridation

- The first occurrence of fluoridated drinking water on Earth was found in Germany's Nazi prison camps. The Gestapo had little concern about fluoride's supposed effect on children's teeth; their alleged reason for mass-medicating water with sodium fluoride was to sterilize humans and force the people in their concentration camps into calm submission. (Ref. book: "The Crime and Punishment of I.G. Farben" by Joseph Borkin.)
- The following letter was received by the Lee Foundation for Nutritional Research, Milwaukee Wisconsin, on 2 October 1954, from Mr. Charles Perkins, a chemist:

*"I have your letter of September 29 asking for further documentation regarding a statement made in my book, *The Truth About Water Fluoridation*, to the effect that the idea of water fluoridation was brought to England from Russia by the Russian Communist Kreminoff."*

"In the 1930's, Hitler and the German Nazi's envisioned a world to be dominated and controlled by a Nazi philosophy of pan-Germanism. The German chemists worked out a very ingenious and far-reaching plan of mass-control which was submitted to and adopted by the German General Staff. This plan was to control the population in any given area through mass medication of drinking water supplies. By this method they could control the population in whole areas, reduce population by water medication that would produce sterility in women, and so on. In this scheme of mass-control, sodium fluoride occupied a prominent place. ... "Repeated doses of infinitesimal amounts of fluoride will in time reduce an individual's power to resist domination, by slowly poisoning and narcotizing a certain area of the brain, thus making him submissive to the will of those who wish to govern him. [A convenient light lobotomy]"

- The real reason behind water fluoridation is not to benefit children's teeth. If this were true, there are many ways in which it could be done that are much easier, cheaper, and far more effective.
- The real purpose behind water fluoridation is to reduce the resistance of the masses to domination and control and loss of liberty. "When the Nazis under Hitler decided to go into Poland, both the German General Staff and the Russian General Staff exchanged scientific and military ideas, plans, and personnel, and the scheme of mass control through water medication was seized upon, by the Russian Communists, because it fitted ideally into their plan to communize the world.

"I was told of this entire scheme by a German chemist who was an official of the great IG Farben chemical industries and was also prominent in the Nazi movement at the time. I say this with all the earnestness and sincerity of a scientist who has spent nearly 20 years' research into the chemistry, biochemistry, physiology and pathology of fluorine--any person who drinks artificially fluorinated water for a period of one year or more will never again be the same person mentally or physically."

CHARLES E. PERKINS, Chemist, 2 October 1954.

- Quoting Einstein's nephew, Dr. E.H. Bronner (a chemist who had also been a prisoner of war during WWII) in a letter printed in The Catholic Mirror, Springfield, MA, January 1952:

"It appears that the citizens of Massachusetts are among the 'next' on the agenda of the water poisoners. There is a sinister network of subversive agents, Godless 'intellectual' parasites, working in our country today whose ramifications grow more extensive, more successful and more alarming each new year and whose true objective is to demoralize, paralyze and destroy our great Republic--from within if they can, according to their plan--for their own possession."

"The tragic success they have already attained in their long siege to destroy the moral fiber of American life is now one of their most potent footholds towards their own ultimate victory over us."

"Fluoridation of our community water systems can well become their most subtle weapon for our sure physical and mental deterioration. ..."

"As a research chemist of established standing, I built within the past 22 years, 3 American chemical plants and licensed 6 of my 53 patents. Based on my years of practical experience in the health-food and chemical field, let me warn: fluoridation of drinking water is criminal insanity, sure national suicide. Don't do it."

"Even in small quantities, sodium fluoride is a deadly poison to which no effective antidote has been found. Every exterminator knows that it is the most efficient rat-killer. ... Sodium fluoride is entirely different from organic calcium-fluoro-phosphate needed by our bodies and provided by nature, in God's great providence and love, to build and strengthen our bones and our teeth. "

- This organic calcium-fluoro-phosphate, derived from proper foods, is an edible organic salt, insoluble in water and assimilable by the human body, whereas the non-organic sodium fluoride used in fluoridating water is instant poison to the body and fully water soluble.

The body refuses to assimilate it.

- Careful, bonafide laboratory experimentation by conscientious, patriotic research chemists, and actual medical experience, have both revealed that instead of preserving or promoting 'dental health,' fluoridated drinking water destroys teeth, before adulthood and after, by the destructive mottling and other pathological conditions it actually causes in them, and also creates many other very grave pathological conditions in the internal organisms of bodies consuming it. SCIENTIFIC DATA – Fluoride and the Brain

(National Research Council, 2006)

"It is apparent that fluorides have the ability to interfere with the functions of the brain."

- Over 40 animal studies showing that prolonged exposure to varying levels of fluoride can damage the brain, particularly when coupled with an iodine deficiency, or aluminum excess.
- 34 human studies linking moderately high fluoride exposures with reduced intelligence.
- 15 animal studies reporting that mice or rats ingesting fluoride have an impaired capacity to learn and remember.
- 12 studies (7 human, 5 animal) linking fluoride with neurobehavioral deficits (e.g., impaired visual-spatial organization);
- 3 human studies linking fluoride exposure with impaired fetal brain development.
- In 2006, the National Research Council (NRC) stated that "it is apparent that fluorides have the ability to interfere with the functions of the brain." In addition to calling for U.S.-based research on fluoride's IQ effects, the NRC expressed concern about fluoride's possible contribution to dementia. According to the NRC:

"Studies of populations exposed to different concentrations of fluoride should be undertaken to evaluate neurochemical changes that may be associated with dementia. Consideration should be given to assessing effects from chronic exposure, effects that might be delayed or occur late-in-life, and individual susceptibility."

(EPA's Neurotoxicology Division Review 2007)

In 2007, scientists from the Neurotoxicology Division of the U.S. Environmental Protection Agency identified fluoride as having "substantial evidence" of "developmental neurotoxicity." A developmental neurotoxin is a chemical that can damage the young, developing brain.

The EPA scientists based their conclusion on studies showing that fluoride exposure during pregnancy can damage the brain of the offspring. Consistent with EPA's assessment, three studies from China have found that the brain of the human fetus can be significantly damaged by the mother's high fluoride intake. While the safe dose for preventing this effect is not yet known, some adults in western countries have higher urinary fluoride levels of fluoride than the mothers in the Chinese studies (=4.3 ppm). (Mansfield 1999; Yu 1996; Dong 1993).

(Harvard Review 2012)

In July of 2012, a team of Harvard researchers published a "meta-analysis" of 27 studies that have investigated the relationship between fluoride and human intelligence. (Choi 2012) The overwhelming majority of these studies found that fluoride exposure was associated with reduced IQ in children. In fact, 26 of the 27 studies that met the Harvard team's inclusion criteria found a relationship between elevated fluoride and reduced IQ. The Harvard team thus concluded that fluoride's effect on the developing brain of children should be a "high research

priority" in countries like the U.S. where, despite mass fluoridation programs, no studies have yet been conducted to investigate the issue.

As noted by Dr. Philippe Grandjean, an environmental health scientist at the Harvard School of Public Health:

"Fluoride seems to fit in with lead, mercury, and other poisons that cause chemical brain drain. The effect of each toxicant may seem small, but the combined damage on a population scale can be serious, especially because the brain power of the next generation is crucial to all of us."

For years health experts have been unable to agree on whether fluoride in the drinking water may be toxic to the developing human brain. Extremely high levels of fluoride are known to cause neurotoxicity in adults, and negative impacts on memory and learning have been reported in rodent studies, but little is known about the substance's impact on children's neurodevelopment. In a meta-analysis, researchers from Harvard School of Public Health (HSPH) and China Medical University in Shenyang for the first time combined 27 studies and found strong indications that fluoride may adversely affect cognitive development in children. Based on the findings, the authors say that this risk should not be ignored, and that more research on fluoride's impact on the developing brain is warranted. The study was published online in *Environmental Health Perspectives* on July 20, 2012.

The average loss in IQ was reported as a standardized weighted mean difference of 0.45, which would be approximately equivalent to seven IQ points for commonly used IQ scores with a standard deviation of 15.* Some studies suggested that even slightly increased fluoride exposure could be toxic to the brain. Thus, children in high-fluoride areas had significantly lower IQ scores than those who lived in low-fluoride areas. The children studied were up to 14 years of age, but the investigators speculate that any toxic effect on brain development may have happened earlier, and that the brain may not be fully capable of compensating for the toxicity.

"Fluoride seems to fit in with lead, mercury, and other poisons that cause chemical brain drain," Grandjean says. "The effect of each toxicant may seem small, but the combined damage on a population scale can be serious, especially because the brain power of the next generation is crucial to all of us."









One problem with geoengineering: Once you start, you can't really stop

Many of the world's nations show few signs of cutting their greenhouse gas emissions anytime soon. That's why, in recent years, more and more climate scientists have been pondering the concept of "geoengineering" as a way to slow the pace of global warming.



When Mount Pinatubo erupted in the Philippines in 1991, it cooled the planet nearly 1 degree Fahrenheit. Geoengineering would work a lot like that. (Arlan N.Aeg/AFP/Getty Images)

One popular method involves spraying reflective particles into the atmosphere to deflect a small portion of Earth's sunlight. Harvard scientist David Keith discussed the pros and cons of the idea at length in a recent interview. **Pros:** It's cheap, easy, and could likely avert some of the worst impacts of global warming, like sea-level rise. **Cons:** It could have lots of unpredictable side effects, like mucking up global rainfall patterns. It's difficult to coordinate. And geoengineering does nothing to address other severe climate impacts, like ocean acidification. But there's one other concern we didn't really touch on in that interview: Once the world *starts* geoengineering, we can't really ever stop — especially if everyone keeps pumping carbon-dioxide into the atmosphere at the same time. Why? Because as soon as we quit spraying those reflective particles into the atmosphere, the Earth will heat up very, very, very rapidly. And sudden climate change is even worse than the kind we already know about.

Ignorantia

Ignorantia juris non excusat: "ignorance of the law does not excuse" or ***Ignorantia legis neminem excusat:*** "Ignorance of the law excuses no one" are legal principles holding that a person who is Unaware of a law may not escape liability for violating that law merely because he or she was unaware of its content.

Thus, it is well settled that persons engaged in any undertakings outside what is common for a normal person, such as running a nuclear power plant, will make themselves aware of the laws necessary to engage in that undertaking. If they do not, they cannot complain if they incur liability.

Omission

"He who has the ability to act on an injustice, but who stands idly by, is just as guilty as he who holds the knife."

A **Criminal act of Omission** is defined as the failure of an official or other citizen to carry out duties incumbent upon him which may cause considerable harm to the interest of the state or to the rights and legitimate interests of citizens.

A criminal omission to act may be committed deliberately or through negligence. To establish a case of criminal omission to act, the following must be ascertained:

- (1) Whether the accused had the duty to carry out certain actions that he is charged with failing to perform;
- (2) Whether the accused was actually capable, in the specific conditions in which he found himself, to carry out the required actions; and
- (3) Whether the accused actually failed to carry out (deliberately or through negligence) this action—that is, whether he in fact did not fulfill the duties incumbent upon him.

In some cases the mere fact of criminal omission to act creates in itself a *corpus delicti*; law provides that a *corpus delicti* obtains if the inaction led to harmful consequences (for instance, in negligence in the fulfillment of duties).

In other words, a causal link between the criminal omission to act and its result must be established. In the criminal law, an **omission**, or failure to act, will constitute an actus reus (Latin for "guilty act") and give rise to liability only when the law imposes a duty to act and the defendant is in breach of that duty.

It is quite clear that those in local, state and the federal government who are committing these acts of subtle genocide are guilty of deliberate and willful crimes against the citizens they took an oath to, and are paid to, protect. Guilty of the "commission" of crimes.



The Lien Claimant does NOT rely on Title 15 as a basis for the "Commercial Lien." ALL commercial processes, by using or relying on notes or paper in Commerce (e.g. Federal Reserve Notes), must bear some sort of Federal tracking code, a County Recorder's number or a serial number, which process must be accessible for inspection at the nearest relevant County Recorder's Office or be widely advertised. When a Lien matures in three (3) months, ninety (90) days, by default of the Lien Debtor through the Lien Debtors failure to rebut the AFFIDAVIT OF OBLIGATION point-for-point categorically, it becomes an accounts receivable in the ordinary sense of a collectable debt upon which assignments, collateralization, and other commercial transactions can be based, hence becomes a Security subject to observation, tracking, and regulation by the United States Securities and Exchange Commission (hereinafter U.S. S.E.C.).

The notation "A Security — 15 USC" is a flag in Commerce telling the U.S. S.E.C. that a speculation account is being established to enforce a lien. The U.S. S.E.C. can then monitor the process.
