

As of 7/29/22 there were over 1 billion Bluetooth devices. Today, 8/14/24 there are now almost 3 billion (2,902,779,521)






## Is 100,000 Enough?

I hardwired our computer, put grounding techniques in place, shielded data cords...and began searching online for more knowledge. I reached out on my Nextdoor.com account and respectfully inquired about the safety of a cell tower in our neighborhood based on what I was learning online from very credible scientific and medical sources. My mind was racing... "Why would anyone put something so deadly on the market by our homes" and yet I knew because it was a big part of the book I'd written, how gov't oversight has failed us and the massive corruption that seems inherent in every agency as collusion with industry for profits has become "the new normal" ...BUT THIS was a whole new level of betrayal of WE THE PEOPLE!

Many days as I read for hours on end, six days a week for 7 months, my eyes would be full of tears seeing what's being done. Yes, wiring your home is good, I have done that to my house as well and I also have wired my house so most of my bedrooms are quiet and do not have these toxic EMI and electrical fields. 

We're literally pouring new technology into our world in many forms and many layers in a way that has NEVER been done before!




**It's gone too far! Meter readings, human reports, wildlife studies say, "it's gone TOO FAR"!**

The World Health Organization has assigned an "ICD Code" International Code for Diagnostics for this condition, which is an undeniable detail that acknowledges harm is in fact possible? If there's an insurance billing code for a condition, with physical symptoms associated with exposure, then it does exist and clearly it's not "rare".

#### PART 1: International Classification of Disease and Functioning

- A. International Classification of Diseases (ICD-10)
- B. International Classification of Functioning, Disability and Health (ICF)

#### A. International Classification of Diseases (ICD-10):

Classification of electromagnetic hypersensitivity (EHS) requires two or more codes.

(The WHO does not use the term "Electromagnetic Hypersensitivity." Rather they call it, "idiopathic environmental intolerance (IEI) attributed to electromagnetic fields (EMF).")

**EHS or IEI should be classified under:**

**(1) Cause – Two codes are available for illness/injury resulting from exposure:**

- W90.0 for exposure to radiofrequency radiation (RFR). Note this includes intermediate frequencies (IF) that flow along wires, microwave radiation (MWR) as well as millimeter waves (mmW).
- W90.8 for exposure to other non-ionizing radiation, for example extremely low frequency (ELF) electric and magnetic fields (EMF) and ground current. <http://apps.who.int/classifications/icd10/browse/2010/en#/W90.8>

**(2) Effects – various classifications are available for the illnesses/injuries caused by the exposure to EMF radiation, for example ...**

**PART 2: Activity Limitations & Participation Restrictions**

- Activity is the execution of a task or action by an individual. Participation is involvement in a life situation.
- Activity limitations are difficulties an individual may have in executing activities.

- Participation restrictions are problems an individual may have in involvement in life situations.
- The Performance qualifier indicates the extent of Participation restriction by describing the person's actual performance of a task or action in his or her current environment. Because the current environment brings in the societal context, performance can also be understood as "involvement in a life situation" or "the lived experience" of people in the actual context in which they live. This context includes the environmental factors – all aspects of the physical, social and attitudinal world that can be coded using the Environmental.
- The Performance qualifier measures the difficulty the respondent experiences in doing things, assuming that they want to do them.
- The Capacity qualifier indicates the extent of Activity limitation by describing the person's ability to execute a task or an action. The Capacity qualifier focuses on limitations that are inherent or intrinsic features of the person themselves. These limitations should be direct manifestations of the respondent's health state, without the assistance. By assistance we mean the help of another person, or assistance provided by an adapted or specially designed tool or vehicle, or any form of environmental modification to a room, home, workplace etc. The level of capacity should be judged relative to that normally expected of the person, or the person's capacity before they acquired their health condition.

### **PART 3: Environmental Factors**

- Environmental factors make up the physical, social and attitudinal environment in which people live and conduct their lives.
- Qualifier in environment, Barriers or facilitator: 0 No barriers 0 No facilitator 1 Mild barriers +1 Mild facilitator 2 Moderate barriers +2 Moderate facilitator 3 Severe barriers +3 Substantial facilitator 4 Complete barriers +4 Complete facilitator

**The odds of a doctor associating any symptoms to EMF's is slim to none as it's just not recognized yet.** You'll be given a Rx drug and sent back to your toxic world because they still think of radiation as a therapeutic tool. For example, when I first met Kendall on facebook, she was running back and forth to the doctor complaining of Afib (irregular heartbeat). I kept telling her to "go see what kind of electric meter is on your house." She'd read the book I published but my tech injury came after the first printing of the book. When they were suddenly burned out in the California Camp Fire of 2018 they were forced into a friend's RV for several months and sure enough, her Afib

completely went away! Apparently, she didn't need that \$800 a month Rx medicine after all. Now can you see how this "machine" can be redistributing your wealth through stealth measures and empowering ideas that don't have our best interest at heart?

**There are many neurological disorders and diseases like dementia and Alzheimer's showing up even in children now.** I'm seeing lots of complaints of Afib (irregular heart rhythms) clots in lungs as well, (pre Covid shots) which may be from phones or utility meters or.... Stomach and gut issues seem to be the latest trend I'm seeing with new phones specifically but also a "bank" of electric meters on the bedroom wall of someone's apartment is the suspect. Recently, after Kendall got past the electric meter issue and survived adrenal cancer she again appeared to be actively dying, getting worse every day. They had hardwired their computer and had their electric meter changed to a true analog meter, so her new cell phone was the likely culprit. She was complaining that her stomach felt "bad, like I'm getting cancer or something". Every day she was deteriorating. I challenged her to turn off her cell phone and not allow any cell phones in her home or in the car for at least 3 days, (not even in airplane mode which in newer phones leaves some emitters functioning). Forty-eight hours later, her health did a complete turnaround! She had her husband change all her alerts to her email and has never touched it again and she's better every day. She said this all began shortly after they were forced into upgrading their phones. She recently gave an account of having 3 mini-strokes, 2 heart ablations, constant Afib (heart out of rhythm), general ill feeling, shaking, anxiety, brain issues (memory, spaciness, easily distracted), Central Nervous System issues, and later had an adrenal gland removed that was cancerous, which according to the \$25 Million government study is one of the things that can happen from exposure to cell phones specifically. She shared that all of her misery began eight years earlier while working in a business that had WIFI. I'm watching another beautiful 21-year-old young lady posting pictures of herself and they've just cut a few feet of her intestines out and she's wearing an ileostomy bag, yet there she is holding that stupid phone which is likely responsible for her having gut surgery in the first place.

When I shared Kendall's cell phone story with a local friend, she realized her stomach hurts if she's on her phone more than 3-4 minutes. She then told her 8 yr old granddaughter who said, "I bet that's why my stomach hurts when I play games on my iPad and maybe that's what's wrong with Mom's stomach and she's on her phone all the time." She also realized that one month after the utility company installed an electronic utility meter, she had a fully ruptured appendix and six months later she had a heart attack.

After my initial injury we bought some meters so we could trace and mitigate wireless issues, which led us into insights about wired issues as well. What was a concerning realization is to have the STATE **LICENSED ELECTRICIANS** we interviewed tell me, "**Ma'am, if you didn't have meters to prove what you're saying we would've thought you were crazy.**" So, essentially these "trained and licensed by the state professionals" had no clue that their

work, done wrong, (according to personal preferences and code-violating methods handed down by mentors), can make people sick?

**State Licensed Electricians weren't familiar with the meters that measure the SAFETY of their work? That is crazy!**

They found a few original light fixtures in my mom's 41-year-old house where the insulation was oxidized, cracked, and left a bare wire touching the metal fixture, and yet nothing tripped. My brother noted that the electrician who did the most recent work installing a new panel seemed like he was "on something" but he didn't think to mention it. Maybe they should pass a random drug test to keep their license. The electricians never did find where the house was grounded. It was purchased AND inspected in 1988, built in 1976. Checking for a healthy ground should be on that list of things to be inspected. The night the electricians installed two 8' copper clad grounding rods and a number 4 wire from the electric panel, I slept for 5 hours straight for the first time in several years, since moving into that house with my widowed mother.

**Who knew that inability to sleep or stay asleep could be a home wiring or electrical issue in the environment or from the type of electric meter on your home?**

We found that the sprinkler system on the outside wall of the fireplace was throwing a dangerous electric field half across our living room where we spend several hours of our evening. There was another dangerous reading running along an entire wall, so we had to open the sheetrock and found a common problem; a staple slammed into the Romex at an angle by a high-powered stapler. I'd learned that even if the insulation isn't broken the wire can sustain an injury and throw a field off into the home and did! Then the Romex was pulled at a 90-degree angle **tightly**, another no-no that can result in a crimp in the small wires and throw off a toxic field and did. There was a screw in a 220 cord behind the stove that a contractor had done and that too can throw out a very toxic field and did. Add this to the appliances running, LED lights shining directly on granite counter tops, which store and transmit energy, and you might understand why being in the kitchen felt like I was being subtly electrocuted! This could easily have led to a wrong medical diagnosis, a wrong treatment, my early demise, and a remaining toxin pouring into the home. Just like carbon monoxide you can't see it, taste it, or smell it but it will create disease and even kill you. I think it's time for an EMF inspection to happen at homes prior to occupancy and perhaps at sale. Certainly, public education needs to happen.

As we continued to unravel, eliminate, and remedy the mass amounts of electrical chaos going on around us and having to train the electricians, while learning ourselves, I kept wondering why nobody in our culture encourages the maintenance and health of our electrical environment and the understanding that it can and does affect our health? Are we really that ignorant? Sadly, the answer is "Yes" and I was about to get a further education and become burdened with the task of waking up humanity.

**THEN, IT GOT REALLY WEIRD AND IT WASN'T JUST ME, THE 'SENSITIVE' ONE BEING AFFECTED!**

**June 9<sup>th</sup>, 2018**, while standing in my back yard, I had a very abnormal experience. It felt like my eyes were going to cross but then the sense became that they were attempting to line up vertically lasting for about 5 seconds. I recall everything turning white but muscularly speaking *it seemed* that my right eye was vertically above my left eye. I got a little woozy but recovered within a few seconds after it stopped. I wasn't sure what to think about it but considered that I was wearing rubber flip flops, so I wasn't grounded to the Earth, was now hypersensitive, and standing .27 miles from a large cell tower. Not being grounded to the Earth meant that any wave form in the area would see me as an upright water filled antenna. I wondered if it was a new symptom of me being "electrohypersensitive" but felt we were doing everything we could do so I went on with my day knowing that most answers usually find their way to me and sure enough...

**June 11<sup>th</sup>, 2018** (2 days later) a similar thing happened to my then 82-yr-old Mom while she was standing in the doorway of my bedroom. **She did not know it had happened to me and she is NOT electro hypersensitive!!!** She described it somewhat differently, she described that both of her eyes seemed to go in opposite directions side to side and hers lasted for 5-10 seconds. I can't help but wonder what might have occurred if this had happened while she was driving her LARGE motorhome? Likely it would've been blamed on her age and her driving privileges taken while the larger issue was ignored! BUT WAIT...

THEN, I met an electrical engineer in the local grocery store a few months later that seemed like an appointment with Destiny. He followed me out and bought a book from me and gave me his card. I called him about six weeks later and we talked for two hours, and he told me that he too had this vertically aligned eye event **but his lasted for several minutes and there were witnesses.** He described several friends at an apartment working on their computers together for a project. At the end of our phone conversation his voice began to quiver, and he said "I say with all humility that I am often the smartest guy in the room. I wish that what you are saying weren't true because it means that we missed something very important in our deployment of these things." He then cried and said, "But I know it is true and frankly, I'm scared." My reply, "You should be scared. Very scared!"

I went to NextDoor.com via Mom's account, and sure enough, there's a post there ON **JUNE 9<sup>TH</sup>, 2018** that showed the new traffic light at Hudson Loop is now activated "be careful, heads up" kind of post.

I then found the following article that begins with "Migratory birds are known to use the geomagnetic field as a source of compass information. **Scientists have shown that oscillating magnetic fields disrupt the orientation behavior of migratory birds.** Researchers found that robins were disoriented when exposed to a **vertically aligned, broadband or a single-frequency field.**" THAT would explain the sense I had that my eyes were aligned vertically! ### *What Happened After the Book Came Out!*

*The book had been out about 18 months when I began having some unusual symptoms and couldn't figure out the source until I upgraded my phone and noticed my hands ached when I held it. A few weeks later I touched the screen of my mom's cell phone, and a pain shot up my arm that radically changed the focus and ultimately the location of our lives.*

*Fortunately, the previous years, the book I'd written, my online connections, and the effort to recover my health had laid a great foundation for God to continue guiding me through these much more treacherous waters.*

*We moved away from the technology dense city of Austin, Texas to the dense forest of the Ozarks in NW Arkansas, where we live deep down in a hollow with no cell service on purpose.*

*Of interest, me being "moved here" was noted in my first adult journal on May 27th, 1990.*

*33 years later (Feb 2023) a poem forced its way into existence to show me the thumbprint of God on the local efforts here I was sent to reveal.*

*That poem revealed that God had me write that entry 33 years ago, when I was 3 weeks and 3 days from turning 33 myself and February of 2023 meant that we'd arrived here 3 years and 3 months earlier...which is why that poem INSISTED on being written that month!*

Again, how does He do that?

Well, YOU have to get on the same page He is about matters of your life.

You have to start seeking and yielding to His will for your life more than your own plans.

I hope to teach and inspire things to help you get there faster.

The world needs more conscious people!

So, we arrived in the Ozarks of NW Arkansas in November of 2019.

At this time, I was still under the impression that I was a "rare duck"

having this condition, I'd come to know as "electromagnetic hypersensitivity".

One month after our arrival, December of 2019, the local Sheriff's 46-yr-old happy healthy wife dropped dead of a heart attack! My eyebrows were raised but we'd just arrived, and I was still unsure of some things so I did nothing.

The next winter, December of 2020, another local woman

whose family owns the hardware store and building that contains the grocery store, was found crawling on the floor and didn't know who she was. They found 5-8 masses on the side of her brain. **It took a while for me to see that while others don't feel it like I do they are being adversely affected.**

I've spent 5 years here writing, calling, and begging for resolution from local, state, and federal level politicians, environmental groups, notified every member of the state board of health and the Newton Country Health Department, Arkansas Electric Cooperatives Assoc, law firms, Game & Fish Commission, EPA, FCC, Arkansas Public Service Commissioners, Disability Rights, DOJ, DOE, Conservtion Groups, Office of Electricity...

NOBODY WILL MOVE AGAINST ANY TECHNOLOGY and at the federal level jurisdiction has been pulled from every oversight agency! That means they sent the sheriff's home so there's nobody to report the crime to as they continue rolling out a historic number of sources just in towers and satellites!

Today, five years later, there are 41 cell towers and 133 antennas in a 3-mile radius of that address.

AntennaSearch.com shows 192 towers and 1130 antennas in a 3-mile radius of 100 Congress Ave, Austin, Texas 78704. Another friend had 443 cell towers and 339 antennas around her San Antonio, Texas home in 2018.

Now it shows 849 cell towers and 261 antennas in a 3-mile radius.

If you think this is about making a phone call, you need to think again!

*The launch of 5G is when I felt the first major shift here in the Ozarks in December of 2021.*

*They moved the sat tv providers to the C band part of the EMR spectrum to accommodate 5G and for reasons I can't articulate it began sending a microwave reading through the satellite tv box that lit me up and maxed out the radio frequency meter. We went w/o television for 5 months until I figured out the work-around.*

*It was quite disappointing and the beginning of my pulling away from organized religion. I actually hoped I could teach others how to develop this gift as I believe this to be an innate skill. We'll see what the future holds.*

*Every session didn't produce a healing, so I had to figure out why and see the lesson that was teaching.*

*Most often, the issues were due to self-indulgence, entitlement, cultural conformity, preferences, and massive ignorance about what's in the grocery store these days presented as food.*

*I saw the need for a book, specifically for ChRxtians, but I certainly didn't intend to write one.*

*Christi "did laundry, danced to the radio, went for a walk..." and thanked me profusely. She then went to Chicago to visit family for three weeks and wrote an amazing testimonial. It truly looked like she was well. Even Charlene, her friend, wrote "every time I see her she looks healed".*

*But then she returned home to California and started getting sick again and six months later she was dead, leaving us with many questions.*

*In the meantime, I had my acute event when I touched the screen of Mom's phone in October of 2016 and was in a fight to survive and relocate. It was my own injury that quenched me into the idea that there was some technology in her environment responsible for her death. I reached out to Charlene with my idea and she responded, "You must be reading my mind. I even went over to her house to see and she lived right by two towers. I even mentioned it to my mom." This is one reason I decided not to spend time on a podcast, at least not now.*

*I woke up in severe vertigo on the morning of July 24th, 2024. The squeal is definitely louder and I'm just no longer willing to accept this. I live with my 88-yr-old mom and if/when she were to need medical intervention I won't even be able to enter the building with her. In hindsight I realized church attendance effectively outfitted me with a pacifier, put me in a tutu, and sent me out on the battlefield, ill-equipped for the actual battle at hand.*

*The consistent theme I see in these "deliver notice" assignments is God giving people an option to "do justly" or "do the right thing". I see Him providing a path to repentance, an option for them to "turn away from serving evil" by harming people or the environment. And while professing "Christian" politicians and "stewards" attend church they apparently don't read their Bible.*

*...Amos 5: 23-24 reads,*

*"Away with your noisy hymns of praise!*

*I will not listen to the music of your harps.*

*Instead, I want to see a mighty flood of justice,  
an endless river of righteous living."*

**Going to church is a lazy man's path if they do nothing else to provide justice and mercy in the world!

*If stewards deny mercy and justice when they have the jurisdiction to act, and "have notice"
